OFFER OF DEDICATION - TEMPORARY CONSTRUCTION EASEMENT

Michael A. Contino and Krista A. Ericson, Husband and Wife as Joint Tenants, the undersigned, being the present title owners of record of the herein described parcel of land, do hereby make an irrevocable offer of dedication to Contra Costa County, a political subdivision of the State of California and its successors or assigns, a temporary construction easement for drainage purposes to expire on completion of the construction of Line A of Drainage Area 33B, over and across, under and through the real property situated in the County of Contra Costa, State of California, as described Parcel Two in Exhibit "A" (written description) and as shown on Exhibit "B" (plat map) attached hereto.

The easement herein offered shall include the right to construct a channel and appurtenant structures for the purpose of constructing Line A of Drainage Area 33B, to enter upon said land with personnel, vehicles and equipment, to remove all trees and vegetation thereon that interfere with the purpose for which the easement herein is offered, to take therefrom and use earth, rock, sand, gravel, for the purpose of excavating, widening, deepening and otherwise rectifying the channel, and for the construction of embankments, fencing, protection works, and appurtenant structures by Contra Costa County, it's officers, agents, and employees, and by persons under contract with it and their employees for drainage purposes.

It is understood and agreed that **Contra Costa County** and its successors or assigns shall incur no liability with respect to such offer of dedication, and shall not assume any responsibility for the offered parcel of land or any improvements thereon or therein, until such offer has been accepted by appropriate action of the Board of Supervisors, or of the local governing bodies of its successors or assigns.

The provisions hereof shall inure to the benefit of **Contra Costa County** and its successors or assigns and will be binding upon the title owner of record and that owner's heirs, successors or assigns.

EXHIBIT "A"

A portion of Parcel "C", as shown on Minor Subdivision No. 19-73 filed July 2, 1973, in Book 28 of Parcel Maps at page 43, Contra Costa County records, described as follows:

Parcel One - Drainage Easement (FCPID 5084)

A strip of land 11 feet in width described as follows:

Beginning at the southwest corner of said Parcel "C" (28 PM 43); thence along the southerly line of said parcel the following four (4) courses: 1) south 47°44′00" east 16.34 feet; 2) south 72°37′30" east 66.80 feet; 3) north 76°50′30" east 199.90 feet; 4) south 79°56′12" east 259.85 feet to a point on the southerly line on the 30 foot strip of land deeded to Contra Costa County as shown on said parcel map (28 PM 43); thence along said southerly line north 60°16′00" west 32.68 feet to a point that will hereinafter be referred to as point "A"; thence leaving said southerly line north 79°56′12" west 231.34 feet; thence south 76°50′30" west 199.16 feet; thence north 72°37′30" west 61.37 feet; thence north 47°44′00" west 13.91 feet to the northwesterly line of said parcel "C" (28 PM 43); thence along said northwesterly line south 42°16′00" west 11.00 feet to the Point of Beginning.

Containing an area of 5,768 square feet of land, more or less.

Parcel Two - Temporary Construction Easement (FCPID 5085)

A strip of land 20 feet in width described as follows:

Commencing at point "A" as described in Parcel One above; thence along the southerly line of said 30 foot strip (28 M 43) north 60°16'00" west 59.42 feet; thence leaving said southerly line north 79°56'12" west 179.50 feet; thence south 76°50'30" west 197.81 feet; thence north 72°37'30" west 51.50 feet; thence north 47°44'00" west 9.50 feet to the northwesterly line of said parcel "C" (28 PM 43); thence along said northwesterly line south 42°16'00" west 20.00 feet; thence leaving said

northwesterly line south $47^{\circ}44'00"$ east 13.91 feet; thence south $72^{\circ}37'30"$ east 61.37 feet; thence north $76^{\circ}50'30"$ east 199.16 feet; thence south $79^{\circ}56'12"$ east 231.34 feet to the Point of Beginning.

Containing an area of 9,439 square feet of land, more or less.

Bearings are based on MS 19-73 (28 PM 43).


