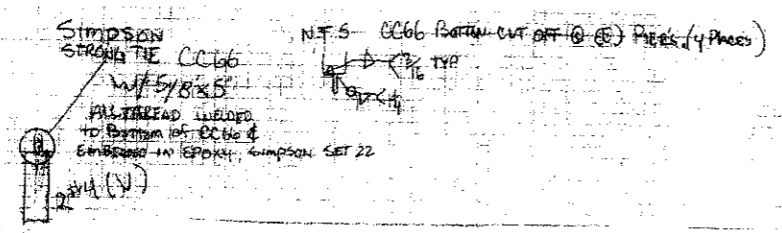

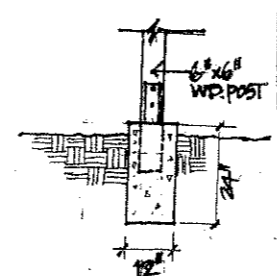
④ FOUNDATION PLAN



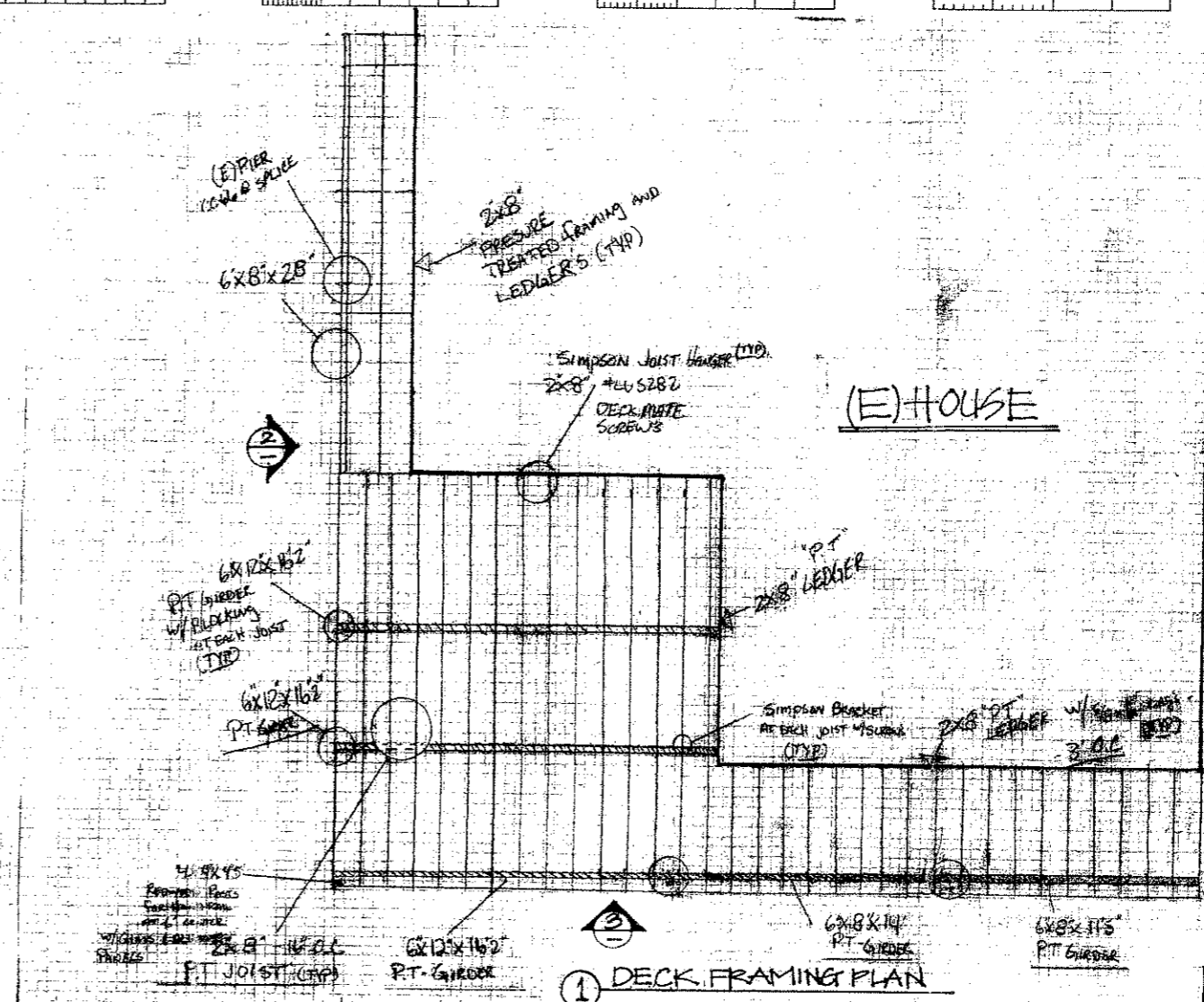
⑤ (N) PIER DETAIL

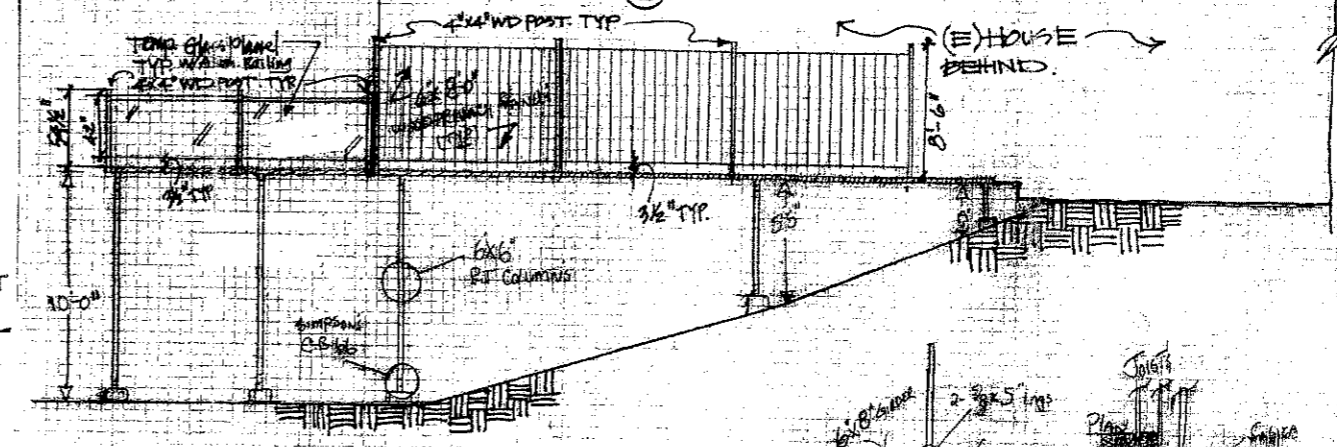

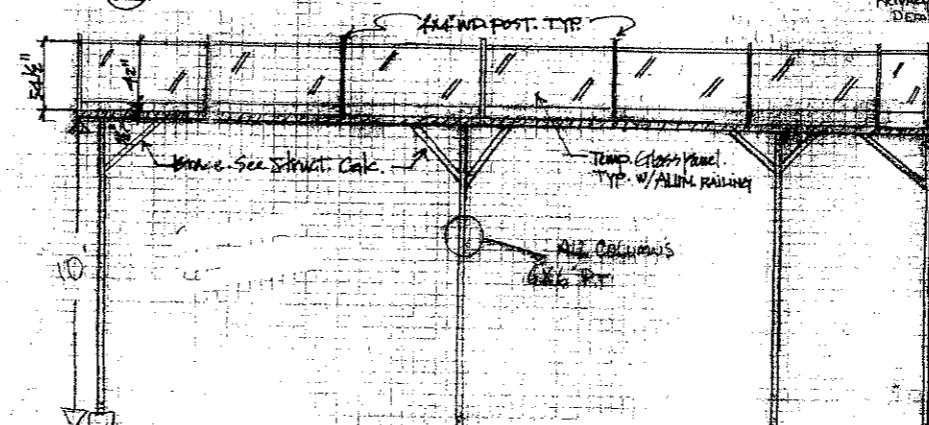
