

ORDINANCE NO. 2011-15

(SUPERVISORIAL REDISTRICTING)

The Contra Costa County Board of Supervisors ordains as follows (omitting the parenthetical footnotes from the official text of the enacted or amended provisions of the County Ordinance Code):

SECTION I. SUMMARY: This ordinance establishes the decennial supervisorial redistricting plan for Contra Costa County as required by Elections Code sections 21500 – 21506, by adjusting the boundaries of the five Contra Costa County supervisorial districts.

SECTION II. This ordinance repeals Article 24-2.2 of the County Ordinance code and replaces it with new Article 24-2.2, added by Section III of this ordinance.

SECTION III. Article 24-2.2 is added to the County Ordinance Code to read:

**Article 24-2.2
Supervisorial Districts**

24-2.202 Census Tracts Used. The supervisorial districts are described by reference to census tracts (CT), census blocks, and block groups used in the 2010 federal decennial census as established by the U.S. Bureau of the Census and filed with the Conservation and Development Director, the exterior boundaries of which are the boundaries of each supervisorial district, except where partial tracts are designated by reference to established local boundaries. When a portion of a census tract is included within the boundaries of a supervisorial district and is described in this ordinance as that portion of the tract located within or outside the boundary of a city, a special district, a state park, or other entity with fixed boundaries, the boundaries of that supervisorial district within that census tract follow the fixed boundaries of those entities as those boundaries existed on July 26, 2011. (Ords. 2011-15, 2001-13, 91-45, 86-90, 82-43, 81-71, 71-87: prior code section 2102: Ord. 1786.)

SECTION IV. EFFECTIVE DATE. This ordinance becomes effective 30 days after passage, and within 15 days of passage shall be published once with the names of supervisors voting for and against it in the Contra Costa Times, a newspaper published in the County.
