WHEREAS, this year's challenge will chart success in numbers of meals provided per employee dollars contributed during the 2011 holiday season to the Food Bank of Contra Costa and Solano; and WHEREAS, the County employees encourage the public to participate by donating funds, food and volunteer energy to the Food Bank of Contra Costa and Solano online in a corresponding "people-to-people" challenge between the counties;

NOW THEREFORE BE IT RESOLVED that the Board of Supervisors of Contra Costa County hereby commends, encourages, and challenges employees and residents of Contra Costa and Solano counties to open their hearts and wallets to assist the Food Bank of Contra Costa and Solano and its client organizations during the coming holiday season; and BE IT FURTHER RESOLVED that the Board of Supervisors of Contra Costa County hereby officially continues the annual challenge with Solano County and kicks off the 2011 "Counties Care Friendly Food Fight"; and BE IT FURTHER RESOLVED that the Board of Supervisors of Contra Costa County hereby encourages all citizens of Contra Costa and Solano counties to extend the generous holiday spirit throughout the year to help those less fortunate.
