AMENDMENT SPECIFICATIONS

The Agreement is hereby amended as follows:

1. Payment Limit (Section 1(e)). Section 1(e) of the Agreement (as amended by Amendment No. 1, 2, and 3, the "Agreement"), is hereby amended as follows:

(a) The Payment Limit for each of the following phases are increased as follow:

Phase 2 - increased by \$5,525

Phase 5 - increased by \$10,230.

(b) The new total Agreement Payment Limit for the Agreement and each phase set forth below shall replace the existing Payment Limits set forth in Section 1(e) of the Agreement:

- c) Consultant will incorporate the assessment determinations into the Natural Environmental Study (NES) and County's cover letter to Caltrans.
