IN THE MATTER OF: Adoption of the "Contra Costa County Hazard Mitigation Plan Update (May 2011)" as the Contra Costa County Flood Control and Water Conservation District's and the Contra Costa County Fire Protection District's Hazard Mitigation Plan, Countywide. (100% Flood Control District Funds) Project No. 7505-6F8227, CP #11-11

WHEREAS, Contra Costa County as one of nine counties in the San Francisco Bay Area region is subject to various earthquake-related hazards, such as ground shaking, liquefaction, fault surface rupture, and tsunamis; and,

WHEREAS, Contra Costa County as one of nine counties in the San Francisco Bay Area region is subject to various weather-related hazards, including floods, landslides, and wildfires; and,

WHEREAS, Contra Costa County recognizes that disasters do not recognize city, county, or special district boundaries; and,

WHEREAS, Contra Costa County is committed to maintain and enhance both a disaster resistant County and region by reducing the potential loss of life, property damage, and environmental degradation from natural disasters, while accelerating economic recovery from those disasters; and,

WHEREAS, Contra Costa County is committed to increasing the disaster resistance of infrastructure, health, housing, economy, government services, education, environment, and land use systems in Contra Costa County, as well as in the Bay Area as a whole; and,

WHEREAS, the Federal Disaster Mitigation Act of 2000 requires all cities, counties, and special districts to have adopted a local Hazard Mitigation Plan to receive disaster mitigation funding from the Federal Emergency Management Agency; and,

WHEREAS, a partnership of 36 Contra Costa agencies, including the County, cities, and special districts, was formed for the purpose of preparing the Countywide Hazard Mitigation Plan; and,

WHEREAS, both the Contra Costa County Flood Control and Water Conservation District (Flood Control District) and the Contra Costa County Fire Protection District (Fire Protection District) are part of the partnership with the County that prepared the Countywide Hazard Mitigation Plan; and,

WHEREAS, an Initial Study/Negative Declaration was prepared for the Countywide Hazard Mitigation Plan Update pursuant to California Environmental Quality Act (CEQA) Guidelines, which determined that no significant effects of the environment would result from adoption of the Countywide Hazard Mitigation Plan; and,

WHEREAS, on June 28, 2011, the Contra Costa County Board of Supervisors adopted Resolution No. 2011/277 adopting the Hazard Mitigation Plan for Contra Costa County, but did not convene as the Board of the Flood Control District and the Fire Protection District to approve the same plan for the Districts.

NOW, THEREFORE BE IT RESOLVED, this Board, having considered the Initial Study/Negative Declaration prepared for this project pursuant to CEQA Guidelines, adopts the Countywide Hazard Mitigation Plan entitled "Contra Costa County Hazard Mitigation Plan Update (May 2011)" as the Flood Control District's and the Fire Protection District's local Hazard Mitigation Plan.
