**RECOMMENDATION**

It is recommended that the attached, amended Appendix A to Governing Board Conflict of Interest Code (approved March 24, 1999, Board Report No. 69-B) be approved.

**FUNDING SOURCE**

**BACKGROUND**

Biennially, the Governing Board is required to review the District's Conflict of Interest Code. The Conflict of Interest Code provides that regulations adopted by the State Fair Political Practices Commission, and the listing of position disclosure categories, are the Conflict of Interest Code for the District. The biennial review results in updates to the appendix to show deletions, additions, or changes of titles for positions required to file a conflict of interest statement. The attached Appendix A shows additions and deletions to the listing of disclosure categories. The attached Appendix B explains the disclosure categories.

After Governing Board review and approval, amended Appendix A and Governing Board Conflict of Interest Code will be forwarded to the County Board of Supervisors for filing, in accordance with requirements of state law.

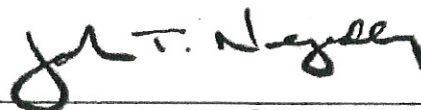
