**Resolution No. 2013/78**

Establishment of a Targeted Employment Area for the Pittsburg/Bay Point Enterprise Zone

WHEREAS, the County of Contra Costa and the City of Pittsburg were awarded a new, 15 year Enterprise Zone in 2012 by the California State Department of Housing and Community Development, referred to as Pittsburg/Bay Point Enterprise Zone; and

WHEREAS, Section 7072(i) of the Government Code allows for the designation of Targeted Employment Areas (TEA) to encourage businesses in an Enterprise Zone to hire eligible residents from Census Tracts that have at least 51 percent of its residents with low or moderate income; and

WHEREAS, only those qualifying Census Tracts within the boundaries of the jurisdictions, specifically unincorporated Contra Costa County and/or the City of Pittsburg, governing an Enterprise Zone may be included in a TEA. Where a Census Tract is shared between a jurisdiction which is a participant in the Enterprise Zone and a non-participant jurisdiction, only those areas within the participating jurisdiction may be included in the TEA; and

WHEREAS, 16 qualifying Census Tracts entirely within the boundaries of the jurisdictions and 64 qualifying Census Tracts partially within the boundaries of the jurisdictions have been identified and mapped.

Now, Therefore, Be It Resolved:

1. The following Census Tracts where applicable, within the territorial jurisdictions of the County of Contra Costa and/or the City of Pittsburg, having been determined to have at least 51 percent of its residents with low or moderate incomes, are hereby identified as those Census Tracts which are in the most need of employment targeting pursuant to Government Code Section 7072(i):
