

**Establish and Name Probation Institutions. Designate Treatment Camp.**

The Contra Costa County Board of Supervisors ordains as follows (omitting the parenthetical footnotes from the official text of the enacted or amended provisions of the County Ordinance Code):

**SECTION I. SUMMARY.** This ordinance amends Section 1102-2.202 of the County Ordinance Code to update the list of established probation institutions. This ordinance also adds Section 1102-2.204 to the County Ordinance Code to designate certain beds at Juvenile Hall for a treatment camp.

**SECTION II. AUTHORITY.** This ordinance is enacted pursuant to Welfare and Institutions Code sections 850, et. seq. and 880, et. seq.

**SECTION III.** Section 1102-2.202 of the County Ordinance Code is amended to read:

**1102-2.202 Establish and name institutions.**

Pursuant to Welfare and Institutions Code Sections 850 ff. and 880 ff., the following juvenile halls, homes, ranches, camps, and forestry camps are established and referred to in this chapter as institutions:

- (1) Contra Costa County Juvenile Hall, at Martinez, California;
  - (2) Contra Costa County Orin Allen Youth Rehabilitation Facility (Ranch), at Byron, California;
  - (3) Contra Costa County Boys' Treatment Camp, at Martinez, California;
  - (4) Community Day Centers in various schools in this County;
  - (5) Contra Costa County Girls' Treatment Camp, at Martinez, California.

**SECTION IV.** Section 1102-2.204 is added to the County Ordinance Code to read:

**1102-2.204 Contra Costa County Boys' Treatment Camp**

Pursuant to Welfare and Institutions Code Section 881, thirty (30) beds at Contra Costa County Juvenile Hall are designated as juvenile camp beds for the Boys' Treatment Camp. The Board of Supervisors may temporarily suspend this designation at any time by resolution. (Ord. 2013-11 §4).
