#### WORKLOAD TRENDS

INCREASE IN DEATH PENALTY CASES
MISDEMEANOR FILINGS – fluctuating PROP 47 MAY CAUSE AN INCREASE

#### **PROPOSITION 47 CHALLENGES**

**NEW BURDENS ON THE DEPARTMENT, BEGINNING NOVEMBER 5, 2014** 

REQUIRES RESENTENCING FOR PERSONS WHO HAVE BEEN CONVICTED OF FELONIES FOR LOW LEVEL THEFT CASES AND SIMPLE DRUG POSSESSION CASES

- Resentencing for persons in prison and local jail COMPLETED
- Resentencing for persons on probation IN PROGRESS – NEED STAFF!
- Reduction of prior convictions to misdemeanor status – NEED STAFF!

## THE NUMBERS ON PROP 47 CASES GOING FORWARD

- NUMBER OF CLIENTS CURRENTLY ON PROBATION WHO NEED TO HAVE PETITIONS FILED:
  - **OVER 1200 on probation caseloads**
  - Several thousand more on court probation
- NUMBER OF CLIENTS WITH PRIOR CONVICTIONS THAT NEED TO HAVE PETITIONS FILED: OVER 25,000 over the next 3 years

#### **STAFFING REQUEST**

**One entry-level attorney position** – to represent clients in court and oversee the case filings

**Two paralegal positions** – to do community outreach and prepare petitions.
