



Access Humboldt strongly supports AB 1262 (Wood), Telecommunications: Universal Service: California Advance Services Fund (CASF), to transfer \$5 million to the Rural and Urban Regional Broadband Consortia Grant Account.

Access Humboldt is a non-profit, community media organization formed in April 2006 to manage local cable franchise benefits on behalf of the County of Humboldt, California and the Cities of Eureka, Arcata, Fortuna, Rio Dell, Ferndale and Blue Lake.

Community media and broadband resources of Access Humboldt include: cable access TV channels; a wide area broadband network with dedicated optic fiber connections to twenty locations serving local jurisdictions, educational institutions and other public facilities; broadband access wireless networks; a Community Media Center with studio and other production equipment and training on the Eureka High School campus; and ongoing operational support for public, educational and governmental access media services from franchised cable operator, Suddenlink Communications.

In 2008, Access Humboldt launched the Broadband Policy Project with funding from ZeroDivide <a href="http://accesshumboldt.net/site/zerodivide-funds-broadband-policy-project">http://accesshumboldt.net/site/zerodivide-funds-broadband-policy-project</a>, to accomplish three goals: to inform public policy deliberations; to convene local discussions of regulatory policies; and, to articulate principles for public interest policies - especially regarding Localism and Diversity.

In 2010, Access Humboldt became the only organization in our region to receive broadband stimulus funds through the NTIA's BTOP program. The "Generation ZeroDivide" project provided training for youth across Humboldt County and adjacent Tribal lands to support digital literacy and broadband media production skills.

For the past three years, Access Humboldt has been collaborating with the California Center for Rural Policy, community anchors in Humboldt County and local stakeholders, serving as lead organization for Humboldt County in the Redwood Coast Region Broadband Consortium.

Rural and urban regional consortia have been working as part of the California Advanced Services Fund's statewide program to address the digital divide, to promote ubiquitous broadband deployment and to advance broadband adoption in unserved and underserved areas throughout the state. AB 1262 would allow consortia to continue working with telecommunication providers and key community stakeholders to promote CASF for years to come.

Access Humboldt believes that AB 1262 is essential to achieving the state's broadband goal of reaching 98% broadband deployment and 80% adoption for California by 2015, goals acknowledged by the California Broadband Council (CBC); California Public Utilities Commission (CPUC); and California Emerging Technology Fund (CETF).

The California Emerging Technology Fund (CETF) respectfully submits this letter to express our strong support for AB 1262 (Wood): Telecommunications: Universal Service: California Advance Services Fund (CASF), to transfer \$5 million to the Rural and Urban Regional Broadband Consortia Grant Account (from the CASF Revolving Loan Account which has unused funds). AB 1262 only provides for a internal transfer of funds within CASF—it does not involve any new fees nor any additional appropriation.

CETF is a statewide non-profit organization directed to be established by the California Public Utilities Commission (CPUC) with the mission to close the Digital Divide in California as a result of corporate mergers in 2005. Thus, CETF is focused on both broadband deployment and adoption, coupled with ensuring accessible technology for people with disabilities.

For the past three years, rural and urban regional consortia have been working to promote ubiquitous broadband deployment and to advance broadband adoption in unserved and underserved areas throughout the state. AB 1262 would allow consortia to continue working with broadband providers and community stakeholders to cost-effectively use CASF funds. Historical data shows that regional consortia have been able to generate information and aggregate demand for the private sector (particularly smaller companies) that foster successful applications to CASF for workable deployment projects to reach unserved households.

AB 1262 is piovtal to achieving the goal of 98% broadband deployment adopted by the Legislature and signed into law in 2013 because high-speed Internet access projects that reach unserved rural communities require cooperation with multiple stakeholders and government agencies that often is either cost-prohibitive or beyond the ability of any single provider. Further, broadband infrastructure projects must to be tailored to the particular circumstances of each community and the assets within a region.

The primary role of the regional consortia is to engage all providers and stakeholders to work together to achieve the 98% deployment goal.

We sincerely thank Assembly Member Wood for introducing this important legislation and we commend the Assembly Utilities and Commerce Committee on your commitment to help close the Digital Divide in California. Attached is a list of letters to date endorsing AB 1262 showing widespread support throughout the state and providing evidence that your leadership to continue funding for the regional consortia is fiscally prudent.

We are writing on behalf of the Connected Capital Area Broadband Consortium (CCABC) to express our strong support for AB 1262, Telecommunications: Universal Service: California Advance Services Fund (CASF), to transfer \$5 million to the Rural and Urban Regional Broadband Consortia Grant Account.

The CCABC is one of 18 consortia in California working to expand connections to and usage of high-speed Internet in underserved communities in Sacramento, Sutter, Yolo and Yuba counties. Valley Vision, a nonprofit social enterprise focused on economic, environmental and social issues in the Sacramento and surrounding regions, manages CCABC.

We work in a region with more than 3 million residents and a footprint of 7,720 miles, from the northern central valley to the peaks of the Sierra Nevada. We recognize how important broadband is to the future of urban centers and rural communities, which is why since our inception we have worked to expand broadband deployment and adoption.

On behalf of the Modoc County Board of Supervisors, and the broadband interests of all Modoc County residents, business owners, educators, students, visitors and public safety/1st responders, I/we support AB 1262 (Wood), Telecommunications: Universal Service: California Advance Services Fund (CASF), to transfer \$5 Million to the Rural and Urban Regional Broadband Consortia Grant Account.

The Northeastern CA Connect Consortium (NECCC) was started in January 2012, and in partnership with its counterpart, the Upstate CA Connect Consortium (UCCC), garnered community support from multiple stakeholders representing twelve counties that fostered development and submission of the Northern CA Regional Middle Mile Infrastructure Plan on 1/31/13. This NC RMMI plan proposed to leverage existing fiber infrastructure, build new routes to connect the currently independent and isolated networks and thereby would have interconnected Modoc to CA's northern counties via redundant and diverse fiber backhaul routes, bringing Modoc County into the 21st Century. Unfortunately, the majority of the proposed project areas were ultimately dis-allowed, hence the entire project was withdrawn due to unsustainability. Today, if efforts to deploy broadband infrastructure throughout northern CA's rural remote areas are to be successful, there is still a great deal of work to be done, because it is the lack of middle mile broadband infrastructure that restricts access to last mile broadband services, whether via land-line fiber, cable, or fixed wireless networks.

We believe the regional broadband planning consortia have made significant progress in promoting the development of broadband deployment projects to advance broadband access in unserved and underserved areas of CA's counties, however, there remain too many barriers deterring both national, regional and local Internet service providers from investing their own capital funds, largely due to lack of return on investment (ROI): rural remote areas by definition lack population density and therefore are not attractive to service providers because they lack potential for enough revenue to be traditionally profitable. For example, Frontier deployed fiber along Rte 299 from Palo Cedro through Alturas out past Cedarville in September of 2010, and has yet to make fiber to the premises (fttp) or fiber to the home (ftth) connections that are affordable to Modoc County residents. Today, the libraries will be able to upgrade their current T-1 lines via CENIC's educational network backbone, yet the Modoc County Administration is still limited to DSL (digital subscriber line), which is as slow as dial-up.



Additionally, through data research and analysis conducted by the Geographical Information Center at CSU, Chico on the CA Broadband Availability data collected by the state, per Round 10 (June 2014), currently there remain 541,118 Households statewide without access to broadband wireline services at or above the state's minimum speeds, representing 4.3% of the entire state's total households. Here in Modoc County, 32.3% of our 4,099 households remain unserved. Should the state decide to raise the minimum speed for broadband to 25 Mgbs down and 3 Mgbs up, 100% of all Modoc County Households will be unserved.

AB 1262 will allow NECCC and other consortia statewide to continue outreach and community efforts to promote development of broadband infrastructure grant applications. Without additional future funding, the work of all seventeen (17) regional broadband planning consortia that commenced in January of 2012 will halt, severely limiting any future efforts in 85% of the state (49 of CA's 58 counties).

We endorse AB 1262, and we recommend language be included in the Bill that specifies the grant funds are to be used by the regional consortia to:

- 1) Assist in the engineering and design of infrastructure projects to meet the unserved and underserved communities across the state;
- 2) Promote the adoption of language that stipulates "broadband is fundamental infrastructure" as part of counties' General Plans; and
- 3) Facilitate the establishment of an ongoing mechanism in every county ensuring that broadband keeps pace with today's evolving standards.

Modoc County Board of Supervisors would like to sincerely thank you, Assembly Member Wood for introducing this important legislation. We commend you on your commitment to help close the broadband divide in California.



On behalf of the Tehama County Board of Supervisors, and the broadband interests of all Tehama County residents, business owners, educators, students, visitors and public safety/1<sup>st</sup> responders, Tehama County is in support AB 1262 (Wood), Telecommunications: Universal Service: California Advance Services Fund (CASF), to transfer \$5 Million to the Rural and Urban Regional Broadband Consortia Grant Account.

The Northeastern California Connect Consortium (NECCC) was started in January 2012, and in partnership with its counterpart, the Upstate California Connect Consortium (UCCC), garnered community support from multiple stakeholders representing twelve counties that fostered development and submission of the Northern California Regional Middle Mile Infrastructure Plan on January 31, 2013. This NC RMMI plan proposed to leverage existing fiber infrastructure, build new routes to connect the current independent and isolated networks and thereby would have interconnected Modoc to California's northern counties via redundant and diverse fiber backhaul routes, bringing Modoc County into the 21<sup>st</sup> Century. Unfortunately, the majority of the proposed project areas were ultimately dis-allowed, hence the entire project was withdrawn due to unsustainability. Today, if efforts to deploy broadband infrastructure throughout northern California's rural remote areas are to be successful, there is still a great deal of work to be done, because it is the lack of middle mile broadband infrastructure that restricts access to last mile broadband services, whether via land-line fiber, cable, or fixed wireless networks.

The County believes the regional broadband planning consortia has made significant progress in promoting the development of broadband deployment projects to advance broadband access in unserved and underserved areas of California's counties, however, there remain too many barriers deterring both national, regional and local Internet service providers from investing their own capital funds, largely due to lack of return on investment (ROI): rural remote areas by definition lack population density and therefore are not attractive to service providers because they lack potential for

enough revenue to be traditionally profitable. For example, Tehama County departments use Internet services provided by multiple ISPs/WISPs, preventing the county from developing its own intra-net. Some departments are still limping along on DSL.

Additionally, through data research and analysis conducted by the Geographical Information Center at CSU, Chico on the California Broadband Availability data collected by the state, per Round 10 (June 2014), currently there remain 541,118 Households without access to broadband wireline services at or above the state's minimum speeds, representing 4.3% of the entire state's total households. Here in Tehama County, 46.9% of our total 24,038 households remain underserved or unserved. Should the state decide to raise the minimum speed for broadband to 25 Mgbs down and 3 Mgbs up, 77.46% of all Tehama County rural Households will be unserved.

AB 1262 will allow NECCC and other consortia statewide to continue outreach and community efforts to promote development of broadband infrastructure grant applications. Without additional future funding, the work of all seventeen (17) regional broadband planning consortia that commenced in January of 2012 will halt, severely limiting any future efforts in 85% of the state (49 of CA's 58 counties).

In our endorsement of AB 1262, it is recommended that language be included in the Bill that specifies that grant funds are to be used by the regional consortia to:

- 1) Assist in the engineering and design of infrastructure projects to meet the unserved and underserved communities across the state;
- 2) Promote the adoption of language that stipulates "broadband is fundamental infrastructure" as part of counties' General Plans; and
- 3) Facilitate the establishment of an ongoing mechanism in every county ensuring that broadband keeps pace with today's evolving standards.

Tehama County sincerely thanks you, Assembly Member Wood for introducing this important legislation. We commend you on your commitment to help close the broadband divide in California.

On behalf of the Kern, West Kern, and Yuba community college districts, I am writing in support of your AB 1262. This bill would transfer funds from the Broadband Infrastructure Revolving Loan Account to the Rural and Urban Regional Broadband Consortia Account to provide another two years of funding for the California Advanced Services Fund (CASF).

Under current law, the Public Utilities Commission (PUC) is required to administer a program, using funds from CSAF, to encourage deployment of high quality advance communication services to all Californians. When CSAF was created the Legislature provided \$10 million to the Rural and Urban Regional Broadband Consortia Grant Account. This account is crucial for providing funds to broadband infrastructure programs in rural areas as well as to consortia that assist in preparing grant applications and educating communities on their broadband needs.

On behalf of the Northeastern CA Connect Consortium (NECCC), and the broadband interests of Butte, Lassen, Modoc, Plumas, Shasta, Sikiyou and Tehama counties, we support AB 1262 (Wood), Telecommunications: Universal Service: California Advance Services Fund (CASF), to transfer \$5 Million to the Rural and Urban Regional Broadband Consortia Grant Account.

NECCC was started in January 2012, and in partnership with its upstate counterpart, UCCC, garnered community support from multiple stakeholders representing twelve counties that fostered development and submission of the Northern CA Regional Middle Mile Infrastructure Plan on 1/31/13. This NC RMMI plan proposed to leverage existing fiber infrastructure, build new routes to connect the currently idependent and isolated networks and thereby would have interconnected 16 of CA's northern counties via redundant and diverse fiber backhaul routes. Unfortunately, the majority of the proposed project areas were ultimately dis-allowed, hence the entire project was withdrawn due to unsustainability. Today, if efforts to deploy broadband infrastructure throughout northern CA's rural remote areas are to be successful, there is still a great deal of work to be done, because it is the lack of middle mile broadband infrastructure that restricts access to last mile broadband services, whether via land-line fiber, cable, or fixed wireless networks.

We believe we have made significant progress in promoting the development of broadband deployment projects to advance broadband access in unserved and underserved areas of our three counties, however, there remain too many barriers deterring both national, regional and local Internet service providers from investing their own capital funds, largely due to lack of return on investment (ROI): rural remote areas by definition lack population density and therefore are not attractive to service providers because they lack potential for enough revenue to be traditionally profitable.

Additionally, through data research and analysis conducted by the Geographical Information Center at CSU, Chico on the CA Broadband Availability data collected by the state, per Round 10 (June 2014), currently there remain 541,138 households without access to wireline broadband speeds at or above 6 Mgbs down and 1.5 Mgbs up (267,048 households are underserved, and 274,090 households are unserved). These under-/unserved households represent 4.3% of the

entire state's total households.

Should the state decide to raise the minimum speed for broadband to 25 Mgbs down and 3 Mgbs up, this number jumps to 854, 587 households that will be unserved, a 64% increase in the number of households statewide that do not have access to broadband services. Of all the statewide households that will be unserved, 68.04% are in rural areas.

AB 1262 will allow NECCC and other consortia statewide to continue outreach and community efforts to promote development of broadband infrastructure grant applications. Without additional future funding, the work of all seventeen (17) regional broadband planning consortia that commenced in January of 2012 will halt, severely limiting any future efforts in 85% of the state (49 of CA's 58 counties).

We endorse AB 1262, and we recommend language be included in the Bill that specifies the grant funds are to be used by the regional consortia to:

- 1) assist in the engineering and design of infrastructure projects to meet the unserved and underserved communities across the state;
- 2) promote the adoption of language that stipulates "broadband is fundamental infrastructure" as part of counties' General Plans; and
- 3) facilitate the establishment of an ongoing mechanism in every county ensuring that broadband keeps pace with today's evolving standards.

Plumas-Sierra Rural Electric Cooperative and Plumas-Sierra Telecommunications support AB 1262 (Wood), Telecommunications: Universal Service: California Advance Services Fund (CASF), to transfer \$5 Million to the Rural and Urban Regional Broadband Consortia Grant Account.

We believe the regional broadband planning consortia have made significant progress in promoting the development of broadband deployment projects to advance broadband access in unserved and underserved areas of California's counties, and recently provided significant data research and technical support for our second CASF Broadband Infrastructure grant application, submitted February 26, 2015 and currently pending review. However, there still remain too many barriers deterring both national, regional and local Internet service providers from investing their own capital funds, largely due to lack of return on investment: rural remote areas by definition lack population density and therefore are not attractive to service providers because they lack potential for enough revenue to be traditionally profitable.

Additionally, through data research and analysis conducted by the Geographical Information Center at CSU, Chico on the California Broadband Availability data collected by the state, per Round 10 (June 2014), currently, there remain 541,138 households without access to broadband wireline services at or above the state's minimum speeds, representing 4.3 percent of the entire state's total households. Should the state decide to raise the minimum speed for broadband to 25 Mbps down and 3 Mbps up, 68.04 percent of all rural households will be **unserved.** 

AB 1262 will allow NECCC and other consortia statewide to continue outreach and community efforts to promote development of broadband infrastructure grant applications. Without additional future funding, the work of all 17 regional broadband planning consortia that commenced in January of 2012 will halt, severely limiting any future efforts in 85 percent of the state (49 of California's 58 counties).

We endorse AB 1262, and we recommend language be included in the Bill that specifies the grant

- 1) assist in the engineering and design of infrastructure projects to meet the unserved and underserved communities across the state;

Dear Assembly Member Wood:

On behalf of the Upstate CA Connect Consortium (UCCC), and the broadband interests of Colusa, Glenn and Lake counties, we support AB 1262 (Wood), Telecommunications: Universal Service: California Advance Services Fund (CASF), to transfer \$5 Million to the Rural and Urban Regional Broadband Consortia Grant Account.

UCCC was started in January 2012, and in partnership with its northeastern counterpart, NECCC, garnered community support from multiple stakeholders representing twelve counties that fostered development and submission of the Northern CA Regional Middle Mile Infrastructure Plan on 1/31/13. This NC RMMI plan proposed to leverage existing fiber infrastructure, build new routes to connect the currently idependent and isolated networks and thereby would have interconnected 16 of CA's northern counties via redundant and diverse fiber backhaul routes. Unfortunately, the majority of the proposed project areas were ultimately dis-allowed, hence the entire project was withdrawn due to unsustainability. Today, if efforts to deploy broadband infrastructure throughout northern CA's rural remote areas are to be successful, there is still a great deal of work to be done, because it is the lack of middle mile broadband infrastructure that restricts access to last mile broadband services, whether via land-line fiber, cable, or fixed wireless networks.

We believe we have made significant progress in promoting the development of broadband deployment projects to advance broadband access in unserved and underserved areas of our three counties, however, there remain too many barriers deterring both national, regional and local Internet service providers from investing their own capital funds, largely due to lack of return on investment (ROI): rural remote areas by definition lack population density and therefore are not attractive to service providers because they lack potential for enough revenue to be traditionally profitable.

Additionally, through data research and analysis conducted by the Geographical Information Center at CSU, Chico on the CA Broadband Availability data collected by the state, per Round 10 (June 2014), currently there remain 541,138 households without access to wireline broadband speeds at or above 6 Mgbs down and 1.5 Mgbs up (267,048 households are underserved, and 274,090 households are unserved). These under-/unserved households represent 4.3% of the

entire state's total households.

Should the state decide to raise the minimum speed for broadband to 25 Mgbs down and 3 Mgbs up, this number jumps to 854, 587 households that will be unserved, a 64% increase in the number of households statewide that do not have access to broadband services. Of all the statewide households that will be unserved, 68.04% are in rural areas.

AB 1262 will allow UCCC and other consortia statewide to continue outreach and community efforts to promote development of broadband infrastructure grant applications. Without additional future funding, the work of all seventeen (17) regional broadband planning consortia that commenced in January of 2012 will halt, severely limiting any future efforts in 85% of the state (49 of CA's 58 counties).

We endorse AB 1262, and we recommend language be included in the Bill that specifies the grant funds are to be used by the regional consortia to:

- 1) assist in the engineering and design of infrastructure projects to meet the unserved and underserved communities across the state;
- 2) promote the adoption of language that stipulates "broadband is fundamental infrastructure" as part of counties' General Plans; and
- 3) facilitate the establishment of an ongoing mechanism in every county ensuring that broadband keeps pace with today's evolving standards.

**UCCC** sincerely thanks you, Assembly Member Wood for introducing this important legislation. We commend you on your commitment to help close the broadband divide in California.
