BE IT FURTHER RESOLVED that the improvements have been constructed in accordance with the Subdivision Agreement and are **ACCEPTED AS COMPLETE**. BE IT FURTHER RESOLVED that there is no warranty period required, and the Public Works Director is **AUTHORIZED** to refund the \$1,000.00 cash security for performance (Auditor's Deposit Permit No. 503408, dated May 22, 2008) plus interest in accordance with Government Code Section 53079, if appropriate, to Gregory M. Capson pursuant to the requirements of the Ordinance Code; and the Subdivision Agreement and surety bond, Bond No. 4368267, dated May 15, 2008 are exonerated.
