I noticed that you had an opening for an At-Large position on the Contra Costa County Aviation Advisory Committee (AAC), and I wanted to submit my application for this position. I have attached the completed BOARDS, COMMITTEE, AND APPLICATION form, as well as my resume, for this position.

Based on my background, I believe that I would make an excellent candidate for this committee position for a number of reasons, including the following, which for convenience I have listed in a bullet format.

- 1. I am a long-standing Contra Costa resident, and lived in the County since I move here from Washington, DC, in 1978.
- 2. I am a forensic and clinical psychologist who has been practicing since I earned my doctorate in 1982 and then became licensed in California in 1984. I specialized in the diagnosis and treatment of persons with addictive disease, and have managed two different alcohol and drug abuse clinics (Oakland & Stockton) for the Kaiser Permanente Medical Group. I retired from Kaiser in 2007 after 21 years.
- 3. After retiring from Kaiser, I expanded my psychology private practice, which has always been located in our county (Martinez & Pleasant Hill), from part time and to include psychological evaluation in a variety of areas, including being on an exclusive FAA list to evaluate pilots and air traffic controllers. I also perform workers' compensation, child custody, disability, and substance abuse evaluations.

4. Lastly, I am also a pilot myself and fly exclusively out of Buchanan (CCR) field. I have just over 900 hours and fly with one of this airport's flying clubs. Therefore, I am also aware of a number of airport and aviation issues since I have been flying out of our airport since the mid nineties.

I look forward to the next steps in this application process, and thank you in advance for your consideration of me for this committee position.
