This letter informs County Welfare Departments (CWDs) and County Probation Departments (CPDs) of the Fiscal Year (FY) 2017-18 Foster Parent Recruitment, Retention, and Support (FPRRS) program planning allocation of \$43.2 million General Fund (GF) based on the Budget Act of 2017. The total amount appropriated for FPRRS funding in FY 2017-18 is unchanged from FY 2016-17.

Counties shall utilize FPRRS funding to recruit, retain, and support foster parents, resource families, and relative caregivers. Counties that receive funding for their approved plans will be required to report the outcomes achieved using these funds and the activities that contributed to those outcomes.

On September 1, 2017, the California Department of Social Services (CDSS) distributed an online survey to collect FPRRS program-related information from CWDs and CPDs

that outlined proposed activities and/or strategies utilizing FPRRS funds. The CDSS will again survey counties seeking information so that it can determine in advance the amount that a CWD or CPD intends to expend for daily child care during FY 2017-18. Thus, the planning amounts could change as a result of the above surveys should any counties not plan to use their full planning allocation.

## <u>CWDs</u>

The CWDs received the same allocations they received as displayed in <u>ACL No. 16-52</u>.

# <u>CPDs</u>

In consultation with the Chief Probation Officers of California, a total of \$15.5 million GF was distributed for those CPDs participating in FPRRS based on the following:

- A planning allocation of \$5 million is distributed to Los Angeles County Probation due to the size of the county.
- The remaining \$10.5 million is distributed based on a percentage of each county's cost related to the Rate Classification Level (RCL) 1 through 14. The RCL costs were calculated based on a point in time of each county's caseload census of youth in group homes (in-state and out-of-state) as of January 1, 2017, and then multiplied by the tiered payment rate for RCLs.
- A minimum floor of \$15,700 was incorporated for each county.

## Reappropriation of Unspent FY 2016-17 FPRRS Funds

The Budget Act of 2017 includes authority to reappropriate unspent FPRRS funds from FY 2016-17 to FY 2017-18, subject to Department of Finance approval. A CFL will be forthcoming to provide information regarding the reappropriation of unspent FPRRS funds.

## **Claiming Instructions**

The amount allocated is GF; therefore, some of these funds may be used as a match for Title IV-E funded child care. Counties are reminded that their FPRRS funds are to be used to supplement, rather than supplant existing funds. County expenditures should be reported to the appropriate claiming codes for the type of costs incurred or administrative activities performed. If claimed expenditures exceed the county's GF allocation, 100 percent of the overmatch will shift to county-only funds. Two separate overmatch codes have been established to track and shift CWD and CPD expenditures that exceed the county allocation amounts on separate ledgers.
