### I. Activities

- Hosted a guest speaker, Principal Planner William Nelson of the County's Advanced Planning Division, at the August 10, 2017 HLAC meeting. Mr. Nelson discussed the role of the General Plan and its relation to historical resources for the County. His presentation assisted the HLAC with its efforts in contributing to the updating of the General Plan.
- HLAC members participated in events held by the East Contra Costa Historical Society (ECCHS), including the opening of their new Kathy Leighton Resource Center.

## II. Accomplishments

- At the Board of Supervisors meeting held on February 7, 2017, the Board adopted the recommendation of the HLAC to include the Rosebrook Estate (66 Sand 67 Stonecastle Court, Alamo) to the County's Historical Resources Inventory.
- At the Board of Supervisors meeting held on February 7, 2017, the Board adopted the recommendation of the HLAC to include an original English Tudor house located within the Diablo Historic District (2067 Alameda Diablo, Diablo) to the County's Historical Resources Inventory.
- At the Board of Supervisors meeting held on September 12, 2017, the Board approved a
  Mills Act Contract for 2067 Alameda Diablo, Diablo. The execution of a Mills Act Contract
  for the property will ensure the restoration and preservation of the County's historical
  resource, an original English Tudor house located within the Diablo Historic District.
- At the Board of Supervisors meeting held on September 26, 2017, the Board approved Mills Act Contracts for both 66 and 67 Stonecastle Court, Alamo. The execution of a Mills Act Contract for each property will ensure the restoration and preservation of the County's historical resource, the Rosebrook Estate.
