Rick co-founded the National September Recovery Month event in Contra Costa and then replicated it at San Quentin. The ARC program, provides free education to San Quentin inmates to become fully certified Alcohol and Other Drugs (AOD) counselors who in turn can provide treatment to other inmates with SUD. Likewise, as part of their reentry plan upon release from prison, ARC participants are prepared to be employed as counselors. Currently, there are two former ARC students working within the AOD System of Care. Rick's dedication to the ARC program, has changed lives and advanced the AOD field in Contra Costa.
