Waiver of Conflict - Bayer Healthcare LLC

Dear Ms. Anderson:

We have been requested to advise the County of Contra Costa ("County") in regard to responding to questions and discussions with Bayer Healthcare LLC ("Bayer") concerning the discount drug pricing program pursuant to 42 U.S.C. Sec. 256b(a) ("the Matter"). As we discussed, the firm currently represents Bayer in various matters that are unrelated to the subject drug pricing discussions with County.

In light of the above and in connection with our requested representation of the County in the Matter, we recognize that conflict of interest issues would arise between the County on one side, and Bayer on the other side. The parties may consent to waive the conflict. By this letter, we are requesting that you consent to waive any objection based on this conflict of interest, and consent to our continued representation of Bayer in unrelated matters.

Our firm is governed by specific rules relating to our representation of clients when potential or actual conflicts of interest may exist, or exist. Rule 3-310(C) of the Rules of Professional Conduct of the State Bar of California reads as follows:

Rule 3-310(C). AVOIDING THE REPRESENTATION OF ADVERSE INTERESTS

- (C) A member shall not, without the informed written consent of each client:
- (1) Accept representation of more than one client in a matter in which the interests of the clients potentially conflict; or
- (2) Accept or continue representation of more than one client in a matter in which the interests of the clients actually conflict; or

> (3) Represent a client in a matter and at the same time in a separate matter accept as a client, a person, or entity whose interest in the first matter is adverse to the client in the first matter.

In accordance with Rule 3-310(C), as set forth above, we request your informed and written consent to continue our current representation of Bayer in unrelated matters, so that we may advise the County in connection with the above-described Matter. Bayer has agreed to waive the conflicts of interest to permit our representation of the County in the Matter. By signing this letter, the County is consenting only to a potential conflict of interest in our current representation of Bayer in unrelated matters; if an actual conflict arises in the course of that representation, Foley & Lardner
