AMENDMENT SPECIFICATIONS

Due to Agency and Consultant's desire to increase the Agreement's payment limit and replace one of Consultant's approved subcontractors, Agency and Consultant hereby amend the Agreement as set forth in this Amendment No.1.

- 1. <u>Payment Limit</u>. Section 4 (Payment Limit) of the Agreement is hereby amended by increasing the payment limit set forth in Section 4 by \$237,000, from \$320,000 to a new payment limit of \$557,000.
- 2. <u>Special Conditions</u>. Special Condition number 3 (Subconsultants) of the Special Conditions is hereby deleted in its entirety and replaced with the following:

"Subconsultants. Pursuant to Section 21 (Assignment) of the General Conditions of this Agreement, Agency hereby consents to Consultant using the following subconsultants to perform services pursuant to this Agreement: (i) BKF Engineers, (ii) H.D. Rueb Structural Engineer, (iii) Engineering Network, (iv) EDesign Engineering, Inc., (v) Camp & Camp Associates, Inc., (vi) JDH Corrosion Consultants, Inc., (vii) Stok Inc, and (viii) Tarrar Properties LLC (each, a "Subcontractor"), provided, that no Subcontractor contract with Agency will include payment provisions with hourly rates in excess of those set forth on Attachment 1 to Appendix B of this Agreement."

- 3. <u>Payment Provisions</u>. The phases of construction payment limit percentages set forth in Section 1(A) of Appendix B are hereby deleted in their entirety and replaced with the following:
 - 1. Construction Administration: \$503,315.00 (90.4% of Payment Limit)
 - 2. Record Drawing and Project Close Out: \$26,725.00 (4.8% of Payment Limit)
 - 3. Reimbursables: \$2,000.00 (.4% of Payment Limit)
 - 4. Additional Services Allowance upon Agency's prior Aurthorization: \$24,960.00 (4.5% of Payment Limit)
- 4. <u>Billing Rates</u>. Attachment 1 to Appendix B (Payment Provisions, Project Personnel and Billing Rates) is hereby deleted in its entirety and replaced with the Attachment 1 to Appendix B attached to this Amendment No. 1.

All other terms and conditions referenced in the original Agreement entered into on April 16, 2019 between Agency and Consultant, not modified by this Amendment No. 1, shall remain in full force and effect.
