- 4. This TCE shall commence on June 1, 2020 and terminate on December 31, 2020. Grantor shall have use of the property until the District takes possession.
- 5. The undersigned Grantor warrants that they are the owner in fee simple of the property affected by this TCE as described in Clause 3 above and that they have the exclusive right to grant this TCE.
