Dear Mr. Petty:

We are in receipt of your letter of November 2020, requesting Project Completion for the above Project. We concur that the documents listed and submitted as attachments to the letter are complete and acceptable to the County.

Before we recommend to the County Board of Supervisors that they accept the Contract for the subject project as complete, we must have your concurrence with the following:

The County may withhold from monies otherwise due, in the amount of \$139,394 for design, materials and/or labor to complete the items listed on the attached "Withhold Summary." Design-Builder shall complete these items in an expeditious manner. If any item is satisfactorily completed prior to the issuance of the retention payment and can be certified as complete, then monies associated with that withhold item can be included in the payment. For those items not satisfactorily completed by January 15, 2021, the County may use the money withheld, in the amount designated at the respective line item, to complete the work, and deduct that amount from the balance due to the design-builder.

If you are in agreement with these conditions, please sign on the line provided at the bottom of this letter and return it to us to serve as notice of agreement. We will need your response by November 20, 2020, in order for the Board of Supervisors to act on acceptance of the contract at their meeting on December 08, 2020.
