SECOND AMENDMENT

to

TRANSPORTATION SERVICE AGREEMENT County Service Area (CSA) T-1 Project

This SECOND AMENDMENT TO TRANSPORTATION SERVICE AGREEMENT is entered into effective this 31st day of December, 2020, (this "Amendment") between the CENTRAL CONTRA COSTA TRANSIT AUTHORITY ("CCCTA"), a joint exercise of powers entity created, existing and in good standing under California Government Code Sections 6500, et seq., and the COUNTY OF CONTRA COSTA, a political subdivision of the State of California ("County").

RECITALS

THE PARTIES ENTER THIS Amendment on the basis of the following facts, understandings and intentions:

- A. The Transportation Service Agreement was entered into effective on January 1, 2014, ("Agreement"), between CCCTA and the County;
- B. The Agreement was previously amended, effective January 1, 2016, to, among other things, extend the term of the Agreement through December 31, 2020. According to the Agreement, its term will expire December 31, 2020, unless otherwise extended;
- C. The County wishes to continue the demand-responsive, flexible, free shuttle service to serve the residents of CSA T-1, as described in the Agreement. The Agreement, as previously amended, includes terms regarding the calculation of annual payments to CCCTA, and the services CCCTA will perform in consideration of said payments. The County desires to remove the expiration date from the Agreement to allow the Agreement to remain in effect until it is terminated by either party;
- D. CCCTA is willing to remove the expiration date, to allow the Agreement to remain effective until it is terminated by either party;

NOW, THEREFORE, in consideration of the mutual covenants and promises of the parties, the parties agree to amend the Agreement as follows:

AGREEMENT

1. <u>Amendments</u>. The Agreement is hereby amended as follows:

<u>Term.</u> Section 1 (Term) of the Agreement is hereby amended by deleting a. the first sentence thereof and replacing it with the following: "The term of this Agreement shall begin on January 1, 2014, and this Agreement shall remain in effect until it is terminated in accordance with Section 16 (Termination of Agreement)." 2. Continuing Agreement. All other terms of the Agreement not modified by this Amendment shall continue in full force and effect.
