Comments

Per conversation with DOF on 1/14/20, for SA with RPTTF overpayment adjustment, Available amount in the PPA form can reflect the adjustment. The ROPS 17-18B RPTTF overpayment adjustment amount was \$130,335 and was captured in ROPS 18-19B. Per DOF ROPS RPTTF Distributions reports, distributed non-admin RPTTF is 2,868,685 (reflecting the adjustment) and admin RPTTF is 125,000 for a total of 2,993,685. Based on revised PPA form per 1/16/20 email from SA, available non-admin RPTTF is 2,801,617 and admin RPTTF is 192,068 for a total of 2,993,685, which is equal to total distributed per DOF reports. Per conversation with DOF on 1/21/20, it is okay for SA to use remaining non-admin RPTTF to fund underfunded admin RPTTF as long as actual is equal or less than authorized. However, "2020-21 Annual Recognized Obligation Payment Schedule" letter dated 4/10/20 issued by DOF shows SA Reported PPA and not CAC Reported PPA:

Our office has contacted DOF regarding this PPA discrepancy, and DOF's response is that, since Pleasant Hill SA did not request a Meet and Confer, DOF has decided that no revision will be made on the letter.

And they mentioned there are two possible options: Pleasant Hill SA can request a Meet and Confer or can submit an Amended ROPS.

The Meet and Confer Request Form must be submitted within five business days of the date of Finance's Annual ROPS determination letter.

However, since the DOF letter is dated 4/10/20, which is past five business days, Meet and Confer Request does not appear to be an option for your SA.

The other option would be Amended ROPS.
