As a recovering addict (2 years clean), issues that surround addiction and recovery are central to my life. I have personally navigated the system in Contra Costa County, having been homeless for nearly a decade, and understand both its strengths and the hurdles it presents to individuals seeking to heal. I am deeply connected to many people still in early recovery, so understand what they are experiencing. As a result of my personal experience, my connections, and my current work (described below), I have ideas about how the County can best serve the recovery community. It is clear to me that the AOD Advisory Board, and the County, are the decisive pillars in supporting available and future progress for recovering addicts. I want to contribute to that progress.

I am an active member of the recovery community in Contra Costa County, through personal recovery work, my employment and my volunteering. I am currently Program Manager of Seeds4Recovery, Support4Recovery's newest program, bringing services into low-income Recovery Residences. This is a program that I co-founded, and brought to S4R, which evidences my ability to envision and implement improvements in services to the recovery community. Since Fall 2019, I have been a House Manager for one of the Recovery Residences managed by Second Chance in Concord. I am active in NA, maintain service commitments and have served as Secretary (2019-2020) and as alternate GSR (2020-current). I am an alumnus of both DVR and Discovery House (from which I successfully graduated from in 2019), so am intimately familiar with living in treatment facilities in Contra Costa County. I also serve as a reporting member of the Support4Recovery board.

Important Information

1. This application and any attachments you provide to it is a public document and is subject to the California Public Records Act (CA Government Code §6250-6270).
2. All members of appointed bodies are required to take the advisory body training provided by Contra Costa County.
3. Members of certain boards, commissions, and committees may be required to: 1) file a Statement of Economic Interest Form also known as a Form 700, and 2) complete the State Ethics Training Course as required by AB 1234.
4. Meetings may be held in various locations and some locations may not be accessible by public transportation.
5. Meeting dates and times are subject to change and may occur up to two (2) days per month.
6. Some boards, committees, or commissions may assign members to subcommittees or work groups which may require an additional commitment of time.
7. As indicated in Board Resolution 2011/55, a person will not be eligible for appointment if he/she is related to a Board of Supervisors member in any of the following relationships: mother, father, son, daughter, brother, sister, grandmother, grandfather, grandson, granddaughter, great-grandfather, great-grandmother, aunt, uncle, nephew, niece, great-grandson, great-granddaughter, first-cousin, husband, wife, father-in-law, mother-in-law, daughter-in-law, stepson, stepdaughter, sister-in-law, brother-in-law, spouse's grandmother, spouse's grandfather, spouse's granddaughter, and spouses' grandson, registered domestic partner, relatives of a registered domestic partner as listed above.
8. A person will not be eligible to serve if the person shares a financial interest as defined in Government Code §87103 with a Board of Supervisors Member.
