

**AMENDMENT NO. 1 TO THE

This Amendment No. 1 (“Amendment”) is made and entered into as of November 29, 2022 (“Amendment Effective Date”), by and between Contra Costa County, a political subdivision of the State of California (“County”), and W.W. Grainger, Inc., an Illinois corporation, (hereinafter referred to as “Grainger”) whose principal place of business is 100 Grainger Parkway, Lake Forest, IL 60045. The County and Grainger are sometimes referred to herein together as the “Parties,” and each as a “Party.” Capitalized terms used but not defined in this Amendment shall have the same meanings as those terms have in the Agreement.

Recitals

Whereas, Grainger offers maintenance, repair, and operations supplies, parts, and equipment under a Master Contract awarded by the City of Tucson, Arizona, and made available to public agencies nationally by OMNIA. The County and Grainger entered into a Participating Addendum, dated November 16, 2021 (“Agreement”), allowing the County to contract with Grainger under the same terms as the Master Contract, subject to certain amendments specified in the Agreement, through December 31, 2022 (the expiration date of the Master Contract).

Whereas, Grainger and the City of Tucson agreed to extend the expiration date of the Master Contract by one year, from December 31, 2022, to a new expiration date of December 31, 2023, with no other changes to the terms of the Master Contract.

Whereas, the Agreement provides that the term may be extended by up to two additional years, one year at a time, provided that the Master Contract remains in effect as of the date the term of the Agreement is extended. The Parties now desire to extend the term of the Agreement through December 31, 2023. This is the first term extension permitted under the Agreement.

Amendment

NOW, THEREFORE, Grainger and the County agree to amend the Agreement, as follows:

1. Term. The expiration date of the Agreement is hereby extended from December 31, 2022, to a new expiration date of December 31, 2023.
2. Remainder Unchanged. Except for the change made by Section 1 of this Amendment, all remaining terms of the Agreement remain unchanged and in full force and effect.
