At the most recent CoH meeting, I observed a motion and dialogue towards HMIS data quality. I agree with the sentiments expressed pertaining to better data may likely yield higher funding via stronger & clearer metrics, which will likely subsequently lead to more & improved services & programs. I would add that while the data gathering and input is fairly streamlined, looking into improvements of such would add to that result, in my opinion. I believe I heard that the VI-SPDAT assessment tool is going to be retired in favor of a more "personal" assessment / assessment tool, and I support the idea of such. I would also like to add that in utilizing the VI-SPDAT, there is a recommendation for what type / level of support for the individual receiving the assessment should receive, and that to streamline & clarify the referral process for that individual towards the service agency receiving the referral, for the individual administering the assessment & referral, would be a welcome addition.



I've coordinated & collaborated with various service agencies within Contra Costa County. I've spent 3-4 years as a director of a local non-profit (Passion to the Streets) in primarily an advisory capacity, and also assisting with events & operational programs as needed. I have completed numerous training courses pertaining to working with vulnerable populations; Crisis Intervention Training (typically for peace officers in dealing with mental health crises), Critical Time Intervention, Motivational Interviewing, Multicultural Awareness, Multicultural Diversity, Trauma Informed Care, Mental Health First-Aid, First Aid CPR & AED, Interviewing, various additional communication & leadership trainings, etc.
