Project Description: Contra Costa County Public Works Department (County), proposes to maintain and rehabilitate various roads in the unincorporated areas described above with slurry seals, chip seals, microsurface seals, cape seals, thin overlays, thick overlays and reconstruction. Pavement preparation consisting of base failure repairs, crack sealing, leveling, patching, edge grinding, etc. will be necessary prior to the surface treatment. Pavement striping and markings will primarily be replaced in kind, although some modifications to accommodate bicycle facilities may be necessary along suitable roads. The project is anticipated to start in the summer of 2022 and take approximately 2-4 weeks at each location depending on the type of treatment. Mill and overlay and chip seal segments will require one-lane traffic closures; slurry seal segments will require half-day street closures; and reconstruction segments may require full day closures. Residents will be notified in advance of construction. No utility relocations, vegetation removal, or right-of-way transactions are anticipated for this project; all work will occur within the County road right-of-way. Appropriate best management practices (BMPs) will be implemented for storm drain inlet protection.

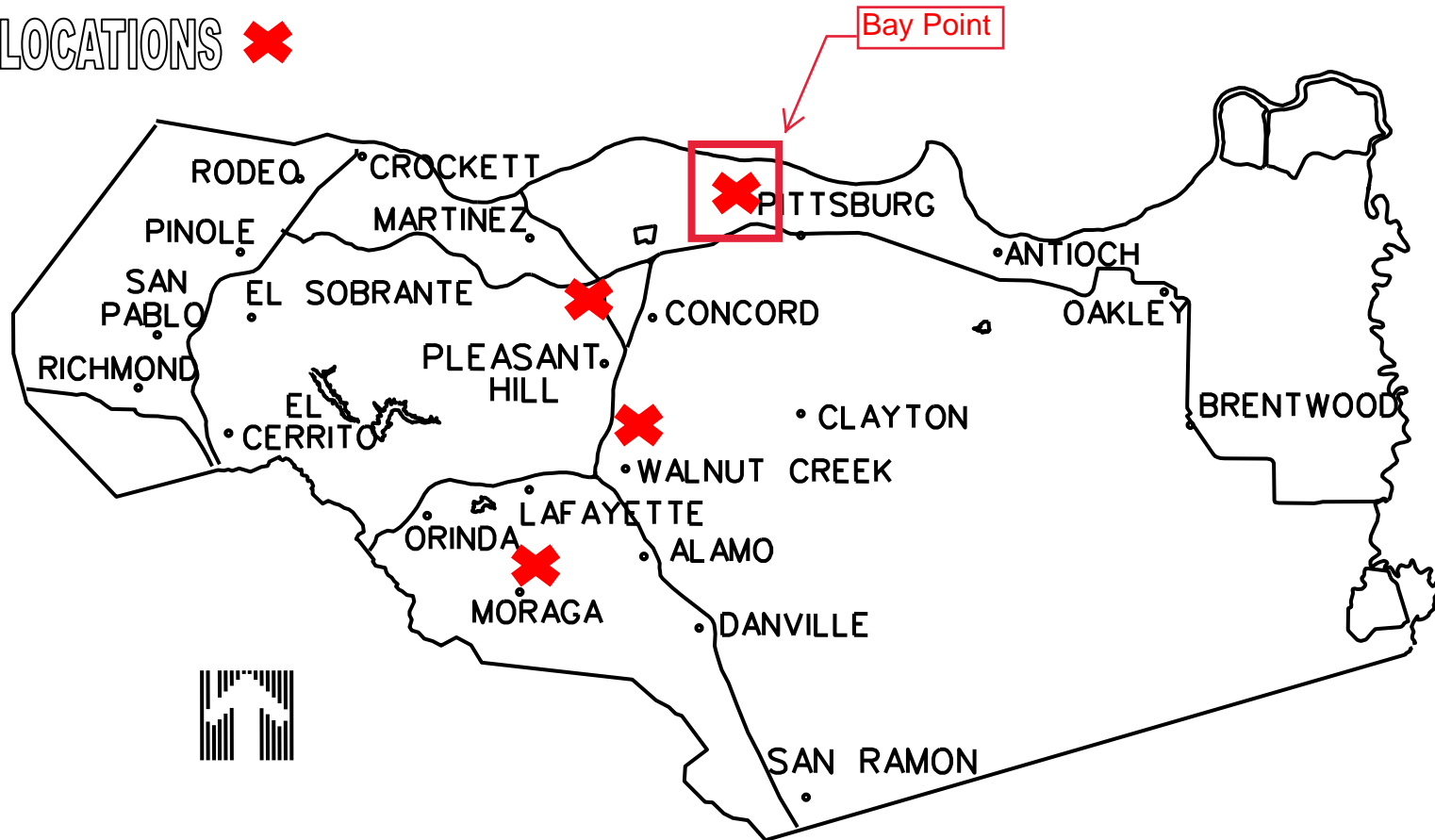


FIGURE 1: Regional Location Map
