I am submitting my name for a position on the Local Planning Council because I would love to serve on the Contra Costa County Local Planning Council. Representing the field of family child care in our county is extremely important to me. I have over thirty years experience working in this county and I am very knowledgeable of the child care field.

Since 2015 I have been the president of our county-wide family child care association. In June, I relinquished this role in pursuit of new adventures in the early childhood development arena. I am still on the board of directors but now will fill the position of Vice President. I further serve on the board of directors for the California Family Child Care Network, our state-wide provider organization. I am a California Early Childhood Mentor Teacher mentoring ECE students from Diablo Valley College in my family child care home for the past six years. Additionally, I am also on the Board of Directors for CocoKids.
Over the past two years I have been working closely with the Childcare Changemakers community (a group of parents, childcare providers/educators and supporters coming together to fight for affordable childcare for every family and living wages for people who work in childcare all over our nation). The Childcare Changemakers will be providing leadership training for national leaders and I am being sent to Washington DC and New Mexico in a couple of weeks to participate.
I am one of a group of three family child providers here in California who presented webinars to support California family child care providers in their individual efforts to complete the grant application process for the Minor Renovation Grant that was due this past March. We had over 1000 providers join us via zoom. With the information that we provided, these family child care care facilities were able to submit their grant applications. We are still waiting to hear how many were granted funds from this process. In 2021 I made a connection with Home Grown (a national collaborative of funders committed to improving the quality of and access to home-based child care.) In June this year, I co-presented with three others from Home Grown, an advocacy workshop called "How to Advocate for Provider Lead Networks". This workshop was presented at the National Association For Family Child Care Conference in San Francisco.
