**Resolution No. 2023/237**

**In The Matter Of:** 2023-2024 California Department of Community Services and Development, Low Income Home Energy Assistance Program Amendment 1

**WHEREAS**, County routinely receives funding from CSD wherein County provides energy bill assistance payments and/or Weatherization services to count residents who are income eligible through the Low Income Home Energy Assistance Program (LIHEAP) and the Energy Crisis Intervention Program (ECIP), and **WHEREAS**, first priority for services are to those households with the following vulnerable populations: young children (ages five years or under), disabled, and elderly persons (ages 60 years or older), and **WHEREAS**, since the execution of the 2023 LIHEAP agreement, 1,552 residents have received energy bill assistance and 88 homes have received weatherization services and **WHEREAS**, the program is operated by the Employment and Human Services Department (EHSD), Community Services Bureau (CSB), and, **WHEREAS**, the Board of Supervisors approved the original revenue agreement to accept funds for the Program Year 2023-2024 in the amount of \$3,367,278 on December 6, 2022 (C.25), and **WHEREAS**, EHSD received notification from the State Department of Community Services and Development (CSD) on April 25, 2023, to amend the 2023 Low Income Home Energy Assistance Program (LIHEAP) agreement 23B-5005, and **WHEREAS**, this amendment (Amendment 1) is the final allocation of 2023 LIHEAP Agreement that CSD is releasing for the grant award, and **WHEREAS**, this board order is to approve the increase of payment limit by \$1,369,345 to a new payment limit of \$4,736,623, and **WHEREAS**, additional funding is to provide services to additional residents that are eligible for the Low Income Home Energy Assistance Program.

**Now, Therefore, Be It Resolved:** the Board of Supervisors approve and authorize the Employment and Human Services Director, or designee, to execute an amendment agreement with the California Department of Community Services and Development to accept additional funds an amount of \$1,369,345 with a new payment limit of \$4,736,623 for the Low Income Home Energy Assistance Program and no change to the term.
