**Resolution No. 2022/367**

In the Matter Of: Agreement Number CF-2223-07 between the California Department of Aging and Contra Costa County.

**WHEREAS**, the United States Department of Agriculture (USDA) funds the Supplemental Nutrition Assistance Program (SNAP), known as CalFresh Healthy Living (CFHL) in California, to provide nutritional benefits to needy individuals and families and allow them to access healthy foods and move towards self-sufficiency, and **WHEREAS**, the USDA launched SNAP-Ed in 1992 to deliver evidence-based projects and interventions to assist people eligible for SNAP/CFHL to live healthier lives on a limited budget, and **WHEREAS**, the Employment and Human Services Department’s Area Agency on Aging (AAA) administers SNAP-Ed in Contra Costa County, through an agreement with the California Department of Aging, to implement policies, systems, and environmental strategies that facilitate healthy life choices and behavior, and **WHEREAS**, through SNAP-Ed, limited-income Contra Costa residents aged 60 years and over participate in evidence-based nutrition education and obesity prevention programs that promote wholesome and balanced food choices, encourage physical activities, and reduce the risk of heart disease, diabetes, and cancer, and **WHEREAS**, through Agreement Number CF-2223-07, the County enters into a contract with the California Department of Aging to receive CFHL SNAP-Ed funding in an amount not to exceed \$585,201 for the period October 1, 2022 through September 30, 2025 to enable the AAA to implement evidence-based nutrition programs for low-income older individuals, and

**Now, Therefore, Be It Resolved:** the Contra Costa County Board of Supervisors approve and authorize the Employment and Human Services Director, or designee, to accept funding in an amount not to exceed \$585,201 from the California Department of Aging for Agreement Number CF-2223-07 for the period October 1, 2022 through September 30, 2025.
