For Tenants

You don't have to move out just because you have received eviction paperwork, but you have to take steps to protect yourself. Once you receive the "Complaint," you have 5 business days to file an "Answer" or else you can lose. Even if you miss the deadline or aren't sure what it is, you should still try to file an Answer as soon as possible. 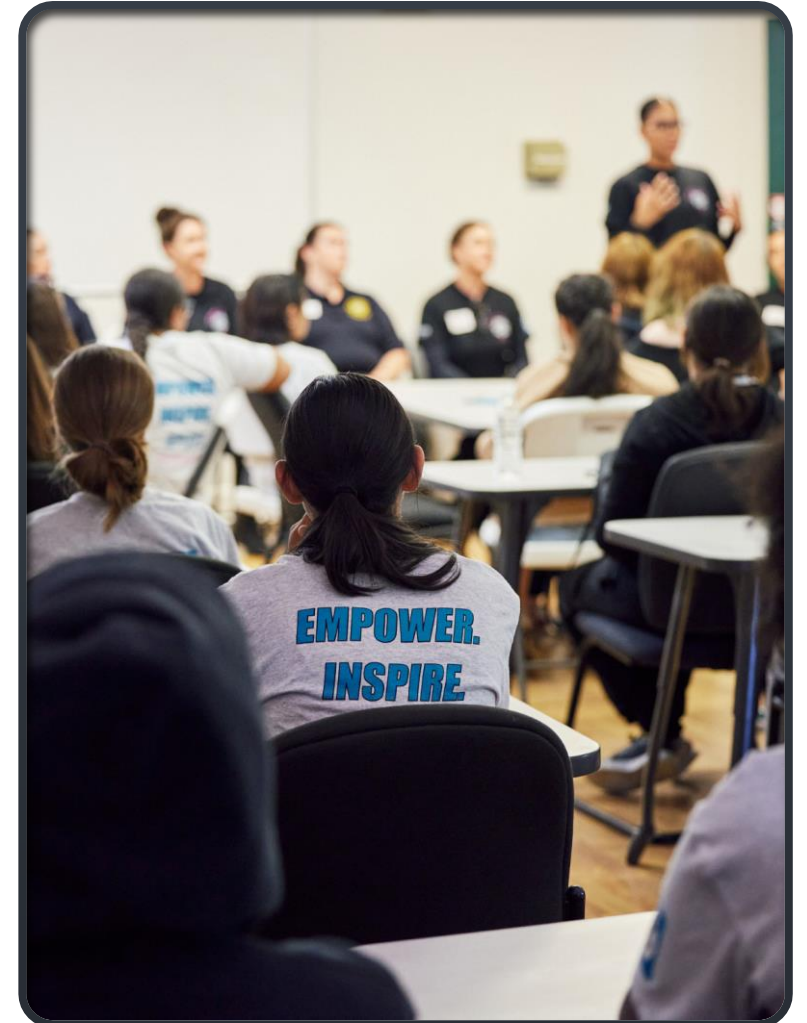

* Government Code 12525.2 requires every law enforcement agency to furnish a monthly report to the Department of Justice, for all instances when a peace officer is involved in any of the following:

- An incident involving the shooting of a civilian by a peace officer
- An incident involving the shooting of a peace officer by a civilian
- An incident in which the use of force by a peace officer against a civilian results in serious bodily injury or death
- An incident in which use of force by a civilian against a peace officer results in serious bodily injury or death

Notable Events

- On May 6, we hosted a Women in Law Enforcement Spring Panel which provided an opportunity for women to gain insight into the many career paths we offer while meeting with many women within our organization who hold a variety of assignments.
- From June 13 to 15, we hosted our second annual Junior Women's Academy. 44 young women from across Contra Costa County learned about career pathways in law enforcement as the remarkable women of the Office of the Sheriff showcased the department's wide variety of assignments and resources.



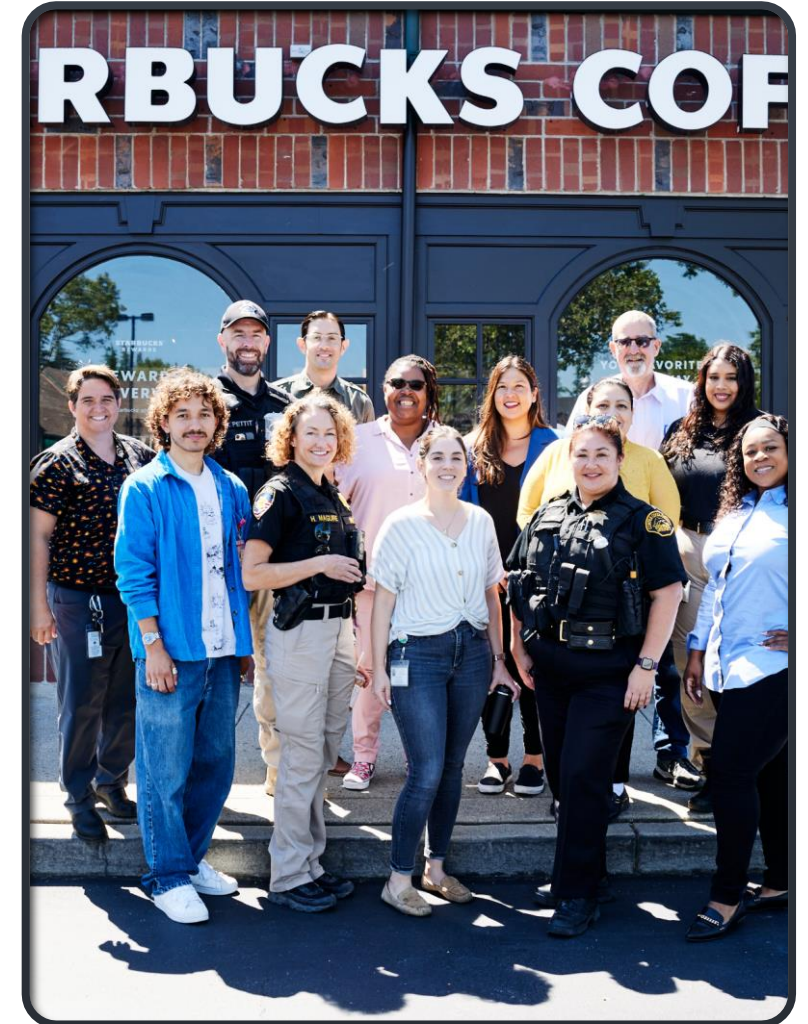
Notable Events

- On April 22, 2023, the Office of the Sheriff held its annual Bay Point Bicycle Rodeo and Safety Fair. The event was sponsored by the Keller Canyon Mitigation Fund, Marathon Renewable, Shell Catalyst, Golden State Water and The Bay Church. 217 bicycles and helmets were provided by free raffle. Over 500 people were in attendance. The prerequisite for entering the raffle is the child must attend one of the five Bay Point schools. Music and food was also enjoyed by all.



Notable Events

- On May 17, the Contra Costa County Office of the Sheriff Mental Health Evaluation Team Deputies (Deputy Jennifer Yen and Deputy Spencer Haran), in cooperation with the San Ramon Police Department, hosted a Coffee with MHET event at the San Ramon Starbucks. The mental health clinicians assigned to MHET, Contra Costa A3 (Anyone Anywhere Anytime) and SENECA Family of Agencies Mobile Crisis Response Team also participated. The event was a two-hour community education and outreach event offering members of the community the opportunity to learn about mental health services offered and available from MHET resources and partners.



Notable Events

- On May 18th, 2023, the Contra Costa County Office of the Sheriff-Office of Emergency Services (OES) conducted a large-scale functional exercise as part of the Bay Area Golden Eagle Exercise. The scope of the scenario consisted of an initial twelve-hour operational response to a wildfire in Briones above Lafayette which moved south into residential areas prompting evacuations and the closure of a major throughway. The Emergency Operations Center was in a Full Activation Status during this exercise.
- Over 120 employees from more than 20 agencies and county departments participated, coordinated, and collaborated. The Office of Emergency Services continues to work with and coordinate with all county departments to incorporate lessons learned and enhance capabilities.
