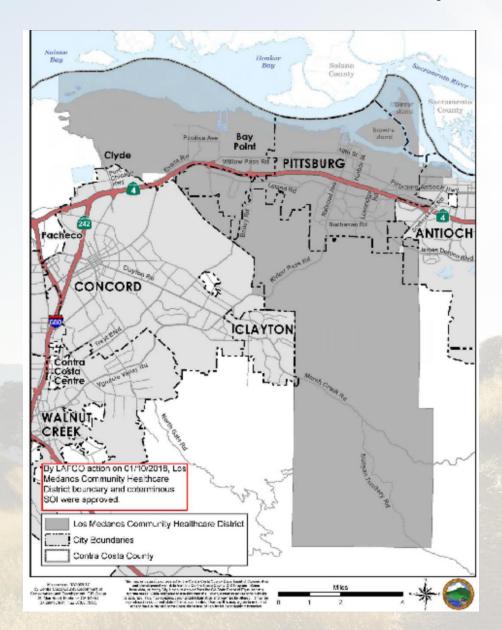

History

- The Los Medanos Community Healthcare District (LMCHD) was a community-based healthcare district that served Pittsburg, Bay Point, and portions of Clayton, Clyde, and Antioch.
- LMCHD was formed in 1948 to operate a hospital within its boundaries. LMCHD operated the Los Medanos Community Hospital until 1994 when the hospital closed due to bankruptcy.
- After 1994, LMCHD did not provide any hospital, physician, or emergency medical services. LMCHD funded third-party agencies that provide health-related programs to the community.

Background

- On July 10, 2018, the Board of Supervisors adopted Resolution No. 2018/436 establishing the Los Medanos Health Advisory Committee to develop and implement the Los Medanos Health Area Grant Program.
- On September 12, 2018, the Contra Costa Local Agency Formation Commission (LAFCo) adopted Resolution No. 17-13B, approving the dissolution of the Los Medanos Community Healthcare District and appointing Contra Costa County as successor agency to the District once the dissolution became effective.

Background, continued

- On March 9, 2022, the Local Agency Formation Commission (LAFCo) recorded a Certificate of Completion (Document No. 2022-0042380) dissolving the Los Medanos Community Healthcare District.
- The terms and conditions of the dissolution appoint Contra Costa County to serve as successor agency of the dissolved District. When LMCHD was dissolved, all previous grants were closed.

Pittsburg Community Garden

- A 0.6 Acre Organic Community Garden on the grounds of the Pittsburg Health Center property
- 81 various sized plots (90% occupied)
- Developing RFI for a master gardener
 - Local community partner
 - Manage gardeners and assigned plots
 - Provide educational programs for gardeners
 - General garden upkeep

Developing a long-term funding strategy

- Complete health assessment to understand the community and needs
 - Data demographics, health disparities, health behaviors, health outcomes
 - Community input and engagement interviews, focus groups, surveys, listening sessions
- Determine funding priorities based on health assessment
- Develop grant program including evaluation metrics, length and amounts of grants to be awarded
- Announce funding opportunities
- Review applications and make recommendations on grant awards
