**WHEREAS**, The Joint-Use Agreement at the San Ramon Educational Center involving the Contra Costa County Library System and the City of San Ramon is a commendable example of a collaboration serving the best interests of Diablo Valley College's students and the community; and

**WHEREAS**, This agreement is an effective collaboration between the college district and the local municipalities to serve students in an effective and efficient manner; and




**WHEREAS**, The two-year agreement with Contra Costa County provides Diablo Valley College students access to the Dougherty Station Library in San Ramon; and

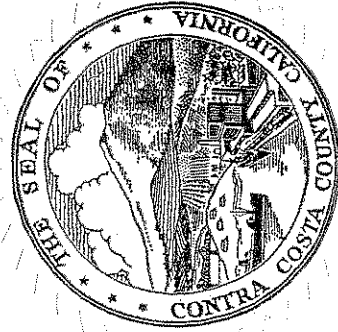
