NOW THEREFORE BE IT RESOLVED that the improvements have been COMPLETED as of February 8, 2011 thereby establishing the six month terminal period for the filing of liens in case of action under said Subdivision Agreement:

BE IT FURTHER RESOLVED the payment (labor and materials) surety for \$8,500.00, Bond No. 136978 issued by the above surety be RETAINED for the six month lien guarantee period until August 8, 2011, at which time the Clerk of the Board is AUTHORIZED to release the surety less the amount of any claims on file.

BE IT FURTHER RESOLVED that the private improvements have been COMPLETED and are NOT ACCEPTED NOR DECLARED as County Roads.

BE IT FURTHER RESOLVED that there is no warranty period required, and the Public Works Director is AUTHORIZED to refund the \$1,000.00 cash security for performance (Auditor's Deposit Permit No. 371627, dated July 17, 2001) plus interest in accordance with Government Code Section 53079, if appropriate, to Steven R. St. Germain and Susan A. St. Germain pursuant to the requirements of the Ordinance Code; and the Subdivision Agreement and surety bond, Bond No. 136978, dated July 20, 2001, are exonerated.

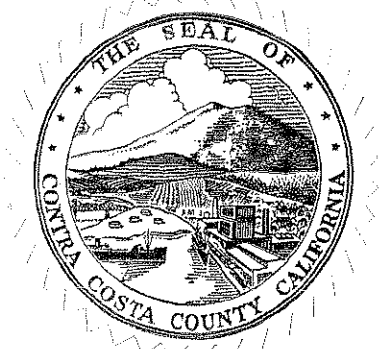
