WHEREAS, John Hanecak began his service on the Pleasant Hill City Council in December of 2004, and was re-elected to the City Council in November 2008 for another four-year term; and

WHEREAS, John Hanecak was selected by the Pleasant Hill City Council to serve as Mayor twice, once in 2008 and again in 2012; and

WHEREAS, John Hanecak served as the Chair of the Pleasant Hill Redevelopment Committee, while also serving on Pleasant Hill's Budget Committee; and

WHEREAS, John Hanecak represented Pleasant Hill as a member of the Association of Bay Area Governments (ABAG); and

WHEREAS, prior to his service on the Pleasant Hill City Council, John Hanecak spent nine years as a member of the Contra Costa Planning Commission, two of those years as Chair; and

WHEREAS, John Hanecak has also been an active member in community organizations such as the Pleasant Hill Rotary Club, the Rotaract Club of Diablo Valley College, Friends of Pleasant Hill Library, Friends of Rodger's Ranch, and served as a past board member on the Pleasant Hill 4th of July Commission; and

WHEREAS, John Hanecak's served as Pleasant Hill's Youth Liaison for over eight years, has taught Speech/Communication Studies at Diablo Valley College (DVC) and has coached the DVC Speech and Debate Team, showing his dedication to our community's youth and the next generation; and

WHEREAS, John Hanecak has received Teacher of the Year awards at St. Mary's College, Fashion Institute of Design and Merchandising, California State University, East Bay, and was named Top California Speech Coach at a national speech & debate tournament; and

WHEREAS, John Hanecak, while having great success as a community leader, has also done so in the corporate world where he developed and managed customized training programs for Fortune 1000 companies and received *Working Women's Magazine* Innovation Award for creating global partnerships; and

WHEREAS, John Hanecak, a resident of Pleasant Hill for over 48 years, has been instrumental in ensuring that Pleasant Hill remains a great place to live, work, play and raise a family.

NOW, THEREFORE, BE IT RESOLVED that the Contra Costa County Board of Supervisors hereby thanks and honors John Hanecak for his dedicated and outstanding service to the residents of Pleasant Hill and Contra Costa County and wishes him well on his retirement from the City Council and in all his future endeavors.
