IN THE MATTER OF initiating proceedings for reversion to acreage of subdivision SD04-08920, subdivided by KPR Balmore Manor, LLC, El Sobrante area. (District I)

WHEREAS, the Board on October 2, 2007, having approved subdivision SD04-08920, located in the El Sobrante area, together with a subdivision agreement with KPR Balmore Manor, LLC, and subdivision bonds issued by Insurance Company of the West for construction of certain road and drainage improvements required for the subdivision; and

WHEREAS, the subdivider has failed to install any of the road and drainage improvements required in the improvement plans for this subdivision;

NOW, THEREFORE, BE IT RESOLVED that the Board hereby INITIATES proceedings for a reversion to acreage of subdivision SD04-08920, as described in Government Code sections 66499.11 through 66499.20.1 and Title 9 of the County Ordinance Code, and AUTHORIZES the Public Works Director, or designee, to prepare a reversion map and take all other actions necessary to complete the reversion.
