IN THE MATTER OF accepting completion of improvements and approving the Parcel Map for minor subdivision MS11-00005, for a project developed by Rudolf Schmid and Gayle Shortridge-Tapscott, Kensington area. (District I)

WHEREAS the Public Works Director has notified this Board that the improvements in minor subdivision MS11-00005 have been completed by Rudolf Schmid and Gayle Shortridge-Tapscott, and that such improvements have been constructed without the need of a subdivision agreement.

NOW, THEREFORE, BE IT RESOLVED that the improvements have been COMPLETED as of June 9, 2015.

The Parcel Map of minor subdivision MS11-00005, a property located in the Kensington area, Supervisorial District I, said map having been certified by the proper officials.

The following document was accompanied by:

1. Letter from the County Tax Collector stating that there are no unpaid County taxes heretofore levied on the property included in said map and that the 2014-2015 tax lien has been paid in full and that the 2015-2016 tax lien, which became a lien on the first day of January, 2015, is estimated to be \$15,300.00.
2. Security to guarantee the payment of taxes, as required by Title 9 of the County Ordinance Code, in the form of a cash deposit (Auditor's Deposit Permit No. DP 684497, dated May 6, 2015) made by Rudolf Schmid and Gayle Shortridge-Tapscott in the amount: \$15,300.00, guaranteeing the payment of the estimated tax.

NOW, THEREFORE, BE IT FURTHER RESOLVED:

1. That said subdivision, together with the provisions for its design and improvement, is DETERMINED to be consistent with the County's general and specific plans.
2. That said Parcel Map is APPROVED and this Board does hereby reject on behalf of the public any streets, paths, or easements shown thereon as dedicated to public use.
