Re: Sale of the Oak Park Elementary School site to the Pleasant Hill Recreation and Park District

Dear Chair Gioia and Supervisors:

Since we last submitted copies of our Advisory Petition to you on Friday, December 4, we wanted to update you on the additional signatures which we have collected on the petition since then. Today, we are submitting an additional 267 signatures on the hard-copy, hand-circulated petition. In addition, another 276 signatures have been collected at the Change.Org website. We sent you a link to that over the weekend, and hope you have had a chance to view the petition there. We have now submitted 1870 signatures to you.

As you know, acquiring the Oak Park Elementary School site by the Pleasant Hill Recreation and Park District is of utmost importance to the residents of Central Contra Costa County. The Park District serves youth and adult recreation enthusiasts throughout the County and even beyond our County's borders. And while the Army Corps of Engineers has turned it's back on helping northern Walnut Creek and southern Pleasant Hill solve our flooding problems, we do not want to lose the land that was set aside for the main detention basin. That basin was part of a Flood Relief Plan that included 3 detention basins and a bypass pipe and has been in place since the 1980's with overwhelming public support, as well as support from the cities of Walnut Creek, Lafayette, and Pleasant Hill.

Once again, we would like to point out that in the new signatures we are submitting to you today, we have calculated the percentage of signatures signed by residents who live outside of the City of Pleasant Hill. We have found that out of the additional 267 hard copy new signatures, 72% of the signatures are from County residents who live outside Pleasant Hill. And from a calculation of the new online signatures, fully 60% are from residents of the County, other than Pleasant Hill.

We hope that you will carefully and thoughtfully consider the many benefits to our County that the playing fields, picnic areas, a detention basin, etc. will give to the current generation of families in Central Contra Costa and the following generations to come.


