RE: The Need for Public Comment and Brown Act Issues

As you may know, I retired as Director of Patients' Rights in September of 2013 for medical reasons, but have kept up some with Contra Costa County mental health issues. Your Committee meeting is critical today, and I would like to stress the following three points:

- 1. The Consolidated Planning Advisory Workgroup [CPAW], this County's body which gives input into Mental Health Services Act [MHSA] planning and expenditures, has not allowed public comment at [at least] its Housing Committee. I refer you to the December 17, 2014 draft meeting minutes and Stan Baraghin's comments, transcribed by me and witnessed by Connie Steers on 1/19/2015 [included]. No meeting which treats consumers as Mr. Baraghin was treated [and he is a Shelter, Inc. County housing client] should be allowed. As a matter of fact, Mr. Baraghin's statement should be appended to the 12/17/2014 minutes. At the 1/21/2015 Housing Committee, Chair Lori Hefner indicated that the draft minutes could be revised. It is important to me that [although Lori Hefner has resigned] the minutes do get revised.
- 2. I have been personally advised to give community input on issues of major concern; but if there is no place on the agenda for public comment, then why should I take the trouble to get to meetings knowing that there is no way to give input?
- 3. I hope that your Committee will recommend to the full Board of Supervisors that the Consolidated Planning Advisory Workgroup [as well as any other county policy-setting bodies] be covered under the Brown Act, with agendas posted and public comment agendized. The least among us [the beneficiaries of the Mental Health Services Act] must attend, and be heard.

Thank you for considering my input.

My name is Stan Baraghan and I cannot read or write. I have been coming to the Housing Committee for about 5 years. Victor Montoya always wanted me to come, and Sandy Rose invited me personally.

With Connie Steers and Janet Marshall Wilson I have reviewed the minutes of the December 17, 2014 Housing Committee meeting. My comments made at the meeting are not in the draft minutes.

I want you to know that:

1-I felt very humiliated at the last Housing Committee meeting, so much that I felt like crying.

2-I felt like I couldn't return to the meetings because I wasn't welcome and don't know how or when I will be able to express my concerns. I know the Chair should have told me when I could speak if she felt I was interrupting a speaker on the agenda, but I had my hand up and Lori Hefner recognized me and I was not interrupting anyone. Where is the place for me to speak on the agenda???

3-I speak for many consumers who can't come and make comments for themselves. I said this at the meeting.

4-Consumers are what MHSA funds are all about and consumers like me, who meet other consumers face to face, need to have a voice. As I said, "These monies are supposed to be for us." I don't know where the money is going but it's not to consumers. I said this at the meeting.

5-What happens to consumers when they aren't prepared for their own place, or don't know how to advocate for themselves affects their ability to stay in their apartments, makes them recycle to the hospital and makes them fail. We need to be keeping consumers from failing. I said this at the meeting. For example, a new tenant just moved in to my building and has no heat in the apartment. Why isn't the non-profit teaching consumers like this one where are the resources. If I've been in a psychiatric hospital about 20 times, do you think I know where to apply for assistance??

The minutes from the December 17<sup>th</sup> Housing Committee should include every word of what I said.

#### Notes from Discussion

Lori Hefner, Chair made a number of comments after chairing this committee for ten months. She asked several questions as to what the Committee called success and what outcomes they wished to see. The members responded by saying: 1) Decent housing, 2) Hearing what others have to say about MHSA housing 3) Improving supports and skills to consumers once moved into housing and 4) Assuring that consumers know how to escalate their issues and concerns to their housing managers and providers.

Lauren advocated that CPAW Housing be present in Sacramento at the MHSAOC meetings. This was discussed at CPAW and we encourage those in appropriate roles to do that. CPAW Committees are not authorized to do that without CPAW coordination.

Lori said we focus on MHSA housing dollars so we can have tangible outcomes. Mental Health Housing is an enormous problem nationally and we ourselves cannot solved national problems. Important but ancillary things like the direction of the national economy and rising rents nationally are outside of the scope of this committee. Much can be discussed but this will result in informational discussions and very few outcomes.

While CPAW use to micro-manage things like "Have the showers at Crestwood started renovation?" We, CPAW, now agree the role of CPAW is not micro-managing these details. The purpose of CPAW is to be advisory to the Director of Behavior Health.

We must keep the duties of the County's Mental Health Commission for inquiry and investigation separate from CPAW approaches. There appears to be an attempt by some MH Commissioners to bypass their own committee structure in favor of using other committees, such as CPAW committees, to address issues that the Commission has either chosen not to address, or that they have specifically refused to address such as housing "site visits." We note these are delicate relationships we must positively manage so providers continue to work with us. Sandy and Jenny have these responsibilities along with Community Care Licensing. We are not to interfere. If concerned Vic has advised us to call Community Care Licensing.

We have been directed by BOS to bring MHSA three-year plan in line with revenues. We are not growing programs. MHSA monies will be reduced in year three of the plan. See Three Year plan on the web site cchealth.org/mentalhealth/mhsa/pdf/mhsa-3-yearplan.pdf.

We are currently in a program evaluation stage so accountability, efficiency and effectiveness are to be studied, analyzed and reported on. This stage requires as much creativity and dedication as was required in the early days so our consumers benefit the most from our limited resources.

We value stakeholders. Yet many of our providers are not comfortable speaking in the meetings and feel they need to "stay off the radar." That hurts everyone because we have much to learn from the providers about how difficult their jobs and pressures are. This also keeps members of this committee ignorant about the complexities of mental health housing.

We recognize that members of this committee want more data, reports, and analysis but we are short on BHA upper management and administrative time. Staff positions were not designed by their managers to give lengthy accounting reports. Again this will require a fine balance. Please "do not let the perfect get in the way of the good." We must work together successfully building on what each person can bring to the table.

The committee expressed a desire to meet for 2 hours each meeting. The first 90 minutes will be as it has been in the past and the other 30 minutes is for those who wish to stay and discuss matters in a less structured, free flowing way. Lisa C will locate a new meeting room.

Lori thanked everyone for their input and dialogue., and advice.
