Dear Judge Becton:

This letter confirms your Judges' Retirement System II (JRS II) retirement elections.

- Your retirement date has been recorded as August 14, 2017, under the JRS II Service Retirement laws, with a commencement date of August 15, 2017.
- You have elected an Unmodified Allowance, which provides you with a benefit factor rate of 75.0000% of an average of your last 12 months of active judicial salary (final compensation).

Please note that your benefit has been calculated with the salary information reported to JRS II by your employer at the time of your retirement. When the updated salary information is reported to JRS II due to the judicial salary increase that has occurred effective July 1, 2016, and July 1, 2017, your benefit will be recalculated accordingly.

- Your monthly allowance is eligible for increases annually for Cost-of-Living Adjustments (COLAs) based upon the Consumer Price Index (CPI). COLAs are effective in January of each year after you have been retired for more than six months.

- Your direct deposit authorization has been received and processed. Your first warrant will be temporarily sent to your designated mailing address. Your direct deposit statements will be available online, through your my|CalPERS account. To sign in or register for a my|CalPERS account, please visit the CalPERS website at www.calpers.ca.gov. If you want to receive paper statements in the mail, please let JRS II know.
- You have elected to enroll into the **UnitedHealthcare Group Medicare Advantage PPO** plan upon retirement. Your retiree medical coverage will take effect on October 1, 2017. The 2017 monthly cost to you for this enrollment will be [REDACTED]

If you have been assessed income-related Medicare Part B premiums and pay more than the Standard Medicare Part B premium [REDACTED] to the Social Security Administration (SSA), you may request from JRS II reimbursement for your income-related premiums. To request the additional reimbursement, please forward a copy of your letter that advised you of how the SSA determined you were subject to the income-related Medicare Part B premiums to JRS II for processing.

- You have elected your retiree dental coverage with Delta Dental and have been enrolled in the **Delta PPO Plus Premier** plan. This coverage is effective October 1, 2017. Your expected monthly deduction from your JRS II monthly benefit for this enrollment is [REDACTED]
- If you wish to continue or enroll in retiree vision coverage, please contact Rowena Tabar with the Judicial Council to help facilitate enrollment in the State-VSP plan. Ms. Tabar can be reached directly at (415) 865-4323. If you do not wish to enroll in the State vision plan at this time, you will not lose eligibility and may contact VSP directly at (800) 877-7195 during any future open enrollment period.

Note: Medical/dental premiums and State contribution rates are contracted annually and therefore subject to change.

Working After Retirement

The Public Employees' Pension Reform Act of 2013 (PEPRA) added sections 7522.56 and 7522.57 to the Government Code (GC) effective January 1, 2013, which set forth post-retirement employment requirements for all retirees.

GC section 7522.57

GC section 7522.57 prohibits a person retired from a public retirement system from receiving his or her retirement allowance if appointed on or after January 1, 2013, to a full-time salaried position with a state board or commission. Please refer to GC section 7522.57 (d) for specific information regarding your options if appointed to a full-time salaried position with a state board or commission.

A retiree appointed to a part-time state board or commission may serve without loss or interruption of benefits. A part-time appointment is defined as an appointment with a salary no more than \$60,000 annually.

GC section 7522.56

GC section 7522.56 specifically excludes retirees from the Judges' Retirement System or Judge Retirement System II who are appointed to serve as a retired judge with the Assigned Judges Program from the provisions of GC section 7522.56.
