Dear Supervisors Gioia, Anderson, Burgis, Mitchoff, and Glover:

I request that you conduct an independent investigation of the policies and procedures at the WCDF and demand the resignation of Sheriff Livingston. Here are four good reasons:

1. Bullying is inappropriate behavior for our country's law enforcement. Sheriff Livingston punishes those who speak out against his practices. He denied dispatch services to the City of El Cerrito, attacked reentry services, and denied CIVIC's access to people in need.
2. His treatment of those in his care is inexcusable. Black people and immigrant people housed in WCDF suffer mental, emotional, and physical abuse daily.
3. It is time to end the Sheriff's contract with ICE. Profiting off the pain in our communities is not a good way to sustain a county budget!
4. Sheriff Livingston ignores the services we do need and his actions do not contribute to criminal justice reform. He is behind the plan to build a new jail which we don't need. If we end the ICE contract, implement bail reform, and find better ways to treat people with mental illness, we don't need to spend more than \$25 million to build a jail.

It's time for Sheriff Livingston to resign! Please begin by initiating an independent investigation.
