Real property in the City of Martinez, County of Contra Costa, State of California, lying within Rancho El Pinole, and being a portion of the parcel of land granted to Contra Costa County in the Grant Deed recorded June 24, 1954 in Book 2337 of Official Records at page 434 described as follows:

Parcel One - Fee

Portion of Parts "E" and "F" Division 1, Rancho El Pinole. Beginning at the southern line of the 100 feet in width right of way of the Atchison, Topeka and Santa Fe Railroad at a western line of the strip of land described in the Final Order of Condemnation dated March 6, 1953, in the Superior Court of the State of California, in and for the County of Contra Costa, Case No. 56075, entitled The County of Contra Costa, plaintiff vs. John M. Hanna, et al, defendants, a certified copy of which was recorded March 6, 1953 in book 2081 of Official Records, page 562; thence from said point of beginning South 20°22' East, along said western line, 24 feet to the northern line of the parcel of land described in the deed from Frank W. Haag, et al, to Crockett Land and Cattle Company, dated May 14, 1930, recorded May 19, 1930, in book 222 of Official Records, page 446; thence South 70°30' West, along said northern line 85.89 feet to the eastern line of the tract of land conveyed as Parcel Two in the grant deed from Contra Costa County to the State of California, recorded March 23, 1966 in book 5083 of Official Records, page 518, being a point on a non-tangent curve, concave to the southeast, a radial to said point bears North 85°07'01" West; thence along said eastern line, having a radius of 210.00 feet, through a central angle of 7°25'35", an arc distance of 27.22 feet to the southern line of said 100 feet in width right of way of the Atchison, Topeka and Santa Fe Railroad; thence North 70°30' East, along said southern line, 72.72 feet to the point of beginning.

Containing an area of 1,911 square feet of land, more or less.

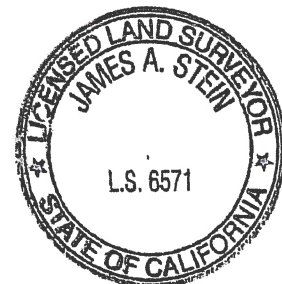
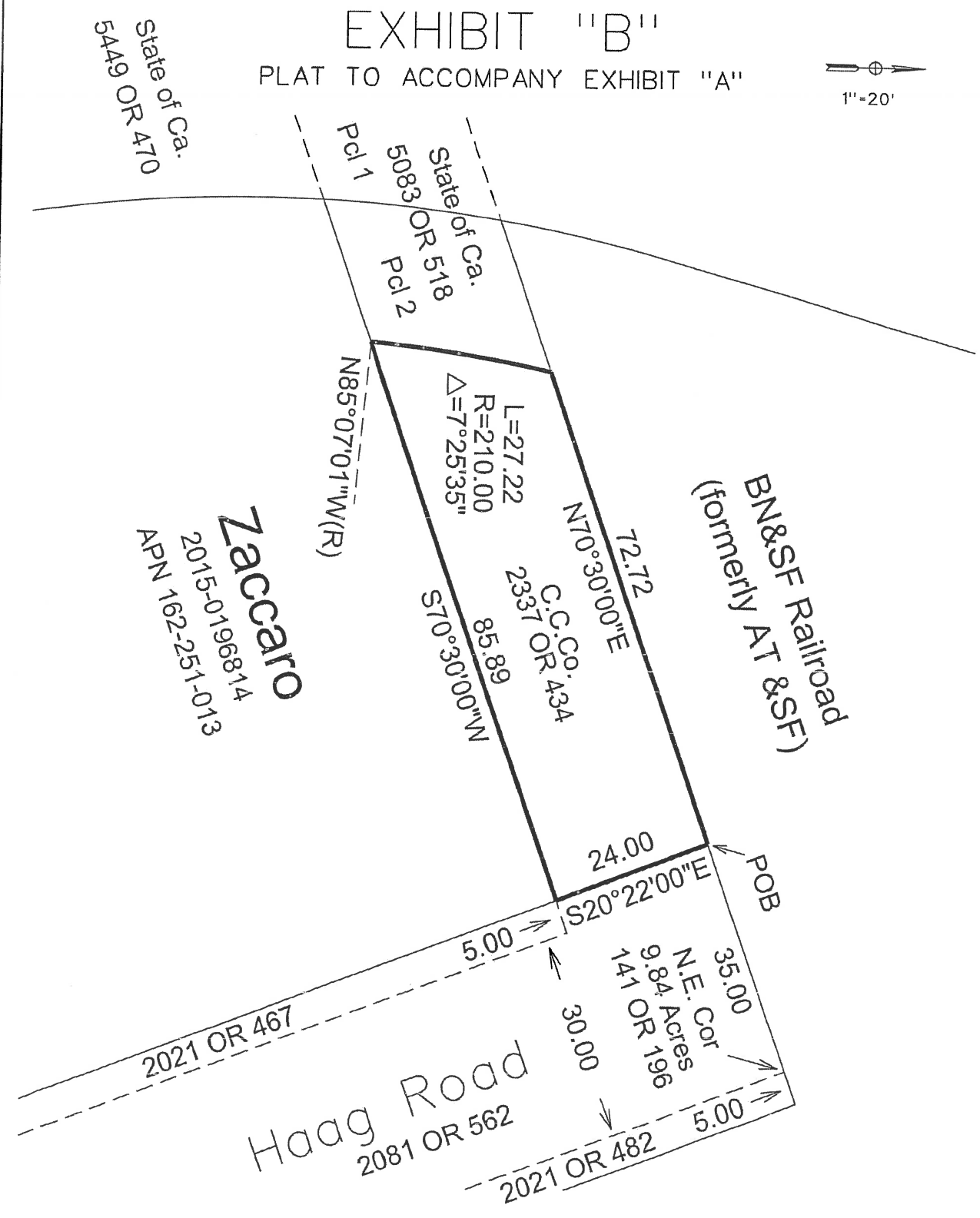
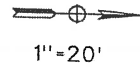
