RE: Fire Chief's Report

-
- Fire Station 16 (Lafayette): The demolition contractor has mobilized, and demolition of the old fire station is in progress. The advertisement to bid is scheduled for January 11, and the pre-bid conference will be held on January 24. Bids are due on February 13, and we anticipate bringing an award package to the Board in March 2018.
 - Fire Station 70 (San Pablo): The architect is now drafting the full construction drawings. In an effort to bring this project forward expeditiously, we expect to meet with the City of San Pablo in February for a pre-submittal meeting when our plans are 75-90% complete. In February, we will submit to the Board a request to engage a construction management firm to assist the Fire District with this project. We remain on track to submit for a building permit in spring 2018 and will go to bid in summer 2018.
 - Fire Academy #51 is at its midpoint with 25 recruits. Graduation is scheduled for February 23, 2018 at the El Campanil Theatre in Antioch.
 - The District's administrative office relocation project is on schedule and will occur the last week of January.
 - The Fire District has completed its second year as the Contra Costa County ambulance contractor. Response time performance continues to be at 96-97%. The District continues to work closely with the County EMS Agency to ensure our citizens are receiving the best possible pre-hospital care.
 - The District was awarded a federal grant to purchase a vehicle-mounted radio repeater that will support public safety in the event that a permanent repeater site is damaged or goes out of service. The actual purchase of the vehicle will occur in late 2018.
 - The Fire District would like to recognize Jackie Lorrekovich, Chief of Administrative Services, and Aaron McAlister, Assistant Chief of Support Services, for earning their Credentialed California County Senior Executive credentials in 2017.

RECOMMENDATION(S):

AUTHORIZE the Auditor-Controller to transfer \$3,000,000 from the CCCFPD EMS Transport Fund (Fund No. 204000) to the CCCFPD General Operating Fund (Fund No. 202000) to reimburse the Contra Costa County Fire Protection District for use of general fund reserves to pay expenditures secured by anticipated receivables from the provision of ambulance services.

FISCAL IMPACT:

This action will result in a \$3 million debit to the CCCFPD EMS Transport Fund (Fund No. 204000) and a \$3 million credit to the CCCFPD General Operating Fund (Fund No. 202000). After this transaction is completed, all initial ambulance service startup funds will be reimbursed and the provision of ambulance services should be fully supported by user fees.

BACKGROUND:

Effective January 1, 2016, the Contra Costa County Fire Protection District (District) became Contra Costa County's exclusive provider of emergency ambulance services within Exclusive Operating Areas 1, 2, and 5.

BACKGROUND: (CONT'D)

No. 2015/449 established the "CCCYPD EMS Transport Fund" for the purpose of providing transparency on the financial transactions associated with the provision of ambulance services and tracking revenue and expenditures generated by the program.

On November 17, 2015, the Board of Supervisors, acting as the Governing Board of the Contra Costa County Fire Protection District, authorized the Auditor-Controller to make transfers from the CCCYPD General Operating Fund to the new CCCYPD EMS Transport Fund to maintain an appropriate fund balance. As with any new venture, initial working capital was necessary to fund operations for a period of time before newly established revenue sources become accessible. The District anticipated a period of negative cash flow (i.e., expenditures are greater than reimbursement revenues), which could result in a deficit in the new fund absent resources from the CCCYPD General Operating Fund.

During the first year of ambulance service, the District relied on its general operating reserve funds to bridge the revenue-expenditure gap. However, now that the District is two years into the venture, provision of ambulance service is financially stable and self-sustaining. The District collects enough revenue through ambulance fees to pay for the cost of providing ambulance services.

Therefore, this action reimburses the District's General Operating Fund for the transfer that was authorized by the Board on November 17, 2015.

CONSEQUENCE OF NEGATIVE ACTION:

Funds will not be reimbursed at this time.

ADOPT Position Adjustment Resolution No. 22209 to add three (3) full time Fire Captain (RPTA) represented positions at salary plan and grade 4N6 1814 (\$7,557-\$10,127), three (3) full time Fire Engineer (RPVC) represented positions at salary plan and grade 4N6 1693 (\$6,703-\$8,983), and three (3) full time Firefighter-Paramedic (RPWB) represented positions at salary plan and grade 4N6 1691 (\$6,690-\$8,965) in the Contra Costa County Fire Protection District.

FISCAL IMPACT:

The estimated cost of this action is \$688,000 for FY 2017-18 (four months). The estimated cost for FY 2018-19 is \$2,180,000. The added positions will be funded out of the District's General Operations Fund (202000).

BACKGROUND:

The Contra Costa County Fire Protection District plans to re-staff a three-person engine company in Walnut Creek. The District currently has 28 recruits in Fire Academy 51. The academy is expected to graduate in mid-February 2018.

The District planned to use nine (9) of these positions to reopen Fire Station 16 in Lafayette. The reopening was originally scheduled for March 2018. However, the construction of Fire Station 16 will not be completed until March 2019. Consequently, the District can use these nine (9) positions to re-staff Engine 1 in downtown Walnut Creek. Engine 1 was de-staffed in January 2011 due to recessionary budget cuts.

nine (9) positions will cover three rotating shifts. An engine company consists of a Fire Captain, Fire Engineer and Firefighter, one of which must be a licensed paramedic. The re-staffing of Engine 1 will provide a much needed and significant increase in the fire and EMS response capacity for Walnut Creek and the surrounding cities and communities. The tentative restaffing of Engine is planned for March 1, 2018.

CONSEQUENCE OF NEGATIVE ACTION:

If these positions are not added, the District will not be able to re-staff the engine company at Fire Station 1 in Walnut Creek or provide the increased fire and emergency medical services to Walnut Creek and surrounding cities and communities.

The current site for Fire Station 9 is 209 Center Avenue in Pacheco. The existing fire station is approximately 2,215 square feet with 1,620 square feet allocated for the apparatus bay. The facility is inadequate in size and function for modern fire support services. The new fire station will be constructed approximately 0.8 miles to the west at the corner of Willow Pass Road and Goble Drive in Bay Point and will be approximately 10,000 square feet.

The new stations will be built to include modern seismic standard, will meet the current ADA requirements, and will have the ability to support modern equipment and apparatus. The stations will be built to provide protection for the community of the next fifty years and will allow for the facility to provide personnel with the components, systems, and features found in a modern fire stations. The estimated cost for the two projects is 10 million dollars.

The County Public Works Department requested Statements of Qualifications ("SOQs") for architectural and engineering services for the fire station projects, including the construction of new Fire Station 86 and Fire Station 9. The Public Works Department received 18 SOQs from interested firms and five firms were shortlisted. A selection committee comprised of County and District staff conducted interviews and ranked and shortlisted firms. RMM Design Group (RRM) was one of the top ranking firms. It is recommended that RRM be awarded the agreement for the subject project.

The Public Works Department will administer the agreement and facilitate project management for the District.

CONSEQUENCE OF NEGATIVE ACTION:

If the agreement is not approved, new fire stations will not be constructed. Delays in construction could increase construction cost significantly based on the recent and expected trends in overall costs of constructing essential use facilities.

CCRFCC also provides dispatch services for the Contra Costa County 911 emergency ambulance system. Approximately 80% of the calls received in the CCRFCC are for emergency medical services.

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Purchasing Agent to execute, on behalf of the Fire Chief, a purchase order with Motorola Solutions, Inc., in an amount not to exceed \$215,000, for the purchase of a 911 voice logging recorder with associated components, software, installation, and training.

FISCAL IMPACT:

The State of California has obligated up to \$122,276 in reimbursement from its State Emergency Telephone Account. The current voice logging recorder quote is \$211,063. The District will fund the remaining \$88,787 from the CCCFPD EMS Transport Fund (204000).

BACKGROUND:

The Contra Costa County Fire Protection District (District) needs to upgrade the voice logging recorder in the Contra Costa Regional Fire Communications Center (CCRFCC). The voice logging recorder logs all incoming and outgoing 911 communications. The District's current recorder is out-of-date and in need of replacement. The vendor no longer supports the existing equipment.

required to keep a record of 911 calls. Logging of calls also assists with the effectiveness of call processing (e.g., instant playback). CCRFCC receives and dispatches calls for the District and provides dispatch services for five other fire districts/departments within the County. CCRFCC also provides dispatch services for the Contra Costa County 911 emergency ambulance system. Approximately 80% of the calls received in the CCRFCC are for emergency medical services.

This equipment is vital to maintaining accurate and legally required medical and fire records.

Subject: 2017 Assistance to Firefighters Grant

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Fire Chief, or designee, to apply for and accept grant funding from the U.S. Department of Homeland Security (DHS), Federal Emergency Management Agency (FEMA), Grant Programs Directorate (GPD), Assistance to Firefighters Grant (AFG), in an amount not to exceed \$1,500,000, for the purchase of automatic chest compression devices and a breathing support unit.

FISCAL IMPACT:

90% Federal; 10% local agency match requirement.

BACKGROUND:

The purpose of the Assistance to Firefighters Program is to enhance the safety of the public and firefighters with respect to fire and fire-related hazards. The funds provide critically needed resources that equip and train emergency personnel to recognized standards, enhance operational efficiencies, foster interoperability, and support community resilience. AFG has three activities: Operations and Safety, Vehicle Acquisition, and Regional Projects. Each activity has its own eligibility requirements.

The Contra Costa County Fire Protection District will apply for projects under both Operations

For Operations and Safety, the District will seek funding for thirty automatic chest compression devices and accessories. To save the lives of sudden cardiac arrest patients, a steady supply of oxygen to the heart and brain is needed. Circulation can be created through chest compression. Performing manual chest compression is both difficult and tiring and impossible in certain situations. Automatic devices provide steady compressions in accordance with the latest guidelines and allow rescuers to focus on other life-saving tasks.

For Regional Projects, the District will seek funding for a breathing support unit. During prolonged emergencies, particularly structure fires, where firefighters are required to wear Self Contained Breathing Apparatus (SCBA), these air bottles will need to be replaced and refilled. Breathing support units have the ability to refill the SCBA bottles at the scene of an emergency.

CONSEQUENCE OF NEGATIVE ACTION:

The District will not be able to take advantage of this funding opportunity.
