UNBA requests that BOS approves \$1300,000 in one-time funding for front line Confresh staff for the following reasons: (10,000 elderly & disabled 55I recipients newly eligible & Colfresh on June 1st (2),000 ABAWD, will face 3 month time limits & strict requirements for colfresh on Sept. 1st. ABAWD, are often homoless, veterous, have indiagnosed disabilities are former foster youth, and will require intensive case management to screen for exemptions & be connected to employment & training programs. Both of these changes will require an invease in stoffing to provide healthy food for those who are most vulnurable in outer communities.

Thank you, Supervisors, County Administrator and Department Directors for your thoughtful and compassionate leadership in Contra Costa County. My name is Jack Avery, and I am the Public Policy Analyst at UWBA.

United Way Bay Area convenes individuals, nonprofits, businesses and government partners to fight for the education, basic needs and financial stability of every person in the Bay Area. While the programs that we fund and develop support thousands of families and individuals in achieving financial stability every year, we know we cannot program our way out of poverty.

Thus, UWBA advocates for sound public policies, that address the intersectional causes of systemic poverty. Providing access to healthy food for those who are elderly, disabled, homeless, or other vulnerable populations, is one of those policies.

UWBA requests that the BOS approves \$300,000 in one-time funding for CalFresh staffing, for the following reasons:

- An estimated 10,000 elderly and disabled SSI recipients will become newly-eligible for CalFresh on June 1st
- This large number of newly eligible applicants will greatly increase the workload of CalFresh intake workers
- Just three months later on September 1st, over 4,000 CalFresh recipients determined to be "able bodied adults without dependents" will become subject to 3 month time limits and harsh work requirements
- Surveys have shown that "ABAWDs" are a diverse population, and are often homeless, veterans, people with undiagnosed disabilities, or teenagers aging out of the foster care system
- "ABAWDs" will require much more intensive case management to ensure that they are properly screened for exemptions and connected to E&T programs and volunteer opportunities.
- Both of these policy changes will require an increase in staffing in order to make sure that those who are most vulnerable in our communities receive the food assistance that they desperately need.
- UWBA supports the CalFresh Partnership's request for an increase in funding for front line staff who can process these applications and provide adequate case management.

Thank you Supervisors, for your time, and UWBA urges you to approve this funding, that will help ensure that those who are most vulnerable in Contra Costa will be able to access healthy food.
