Good afternoon. Yesterday, after public testimony regarding Item C 81, the CCAS SET report, Supervisor Mitchoff indicated that review of the Animal Benefit Fund would be done by the Finance Committee. This was after testimony was received that to continue funding the SET program at the current level would decimate the shelter's safety net, the Animal Benefit Fund (donation account).

If the SET contract comes up for renewal in June and the 2018/19 Animal Benefit Fund report won't be heard until the fall, how will the Board be able to assess the funding impact prior to consideration of the contract renewal?

It is important to note that the SET contract/program was not mentioned in the 2017/18 Animal Benefit Fund Review even though \$400,000 was allocated during that time period. Hi Lisa. Thanks for the response. May I get a response to the two questions I asked on March 13th? See above email. Supervisor Mitchoff was the lead at both (June 2018 and March 2019) hearings on this matter. She also promised her constituents in writing that the program would be reviewed but the contract was placed on consent for a late June hearing. At that time, in response to public questions, Supervisor Mitchoff explained that it was too late in the process to make any changes to the contract.
