My job is considered an essential position within Children and Family Services. As a Childrens Services Clerical Specialist, I am only 1 of 7 people in the county who do my job assisting Social Workers and Eligibility Workers. While I absolutely love my job and feel that I am great at it, one thing you do not know about me is that I am also a High Risk Immunocompromised patient with Lupus and Shrinking Lung Syndrome. Along with my health conditions, I am now also 3 months pregnant. All of these things put me at an extreme high risk for catching COVID-19. I have been self-isolating myself in my home for the last 2 weeks, and luckily have not gotten sick. I can't imagine that would be the same story if I came into work. In addition to that, both of my children ages 10 and 6 are out of school until at least May 4 and I am left with no child care. My only care provider was my mother-in-law who works in a hospital and refuses to care for them during this pandemic, to avoid bringing home this disease. This leaves me as their only provider. Because I love my job and doing what I do, I have requested that I work from home. Due to the nature of my job, I am told THIS IS NOT AN OPTION FOR ME (despite efforts to prove that I can do my job at home). Because of this, I am grateful the County agreed to pay us thru April 6. Due to my sickness, I do not have very many accruals (maybe 20 total), so the fact that the County agreed to pay us without the use of accruals has saved my family thru much more hardship. Now that the shelter-in-place order has been pushed back thru at least May 1st, I am now at a new crossroad. I am told the County may not continue to pay us. Because of this, if I am forced to stay home, I will be completely without pay (since I have almost no accruals) just tr
