The coalition's request is simple and RCF and I personally stand with them in support of this request:

- Establish a community-based process to develop a funded, robust Office of Racial Justice and Social Equity
- Explicitly utilize values & priorities based budgeting principles and practices
- Incorporate racial justice and equity analysis in FY 20-21 budget priorities and development
- Significantly increase the percentage of the budget for health and safety net services
- Provide meaningful opportunities for community input into budget deliberations and decision making

Foundations, like us, are also engaged in these conversations together to ensure that philanthropic dollars are allocated based on the values of equity and justice.

I have comments on two items on the June 23, 2020 BOS meeting.

## Item 1 - D.5 Election presentation

I appreciate the thorough report with all the specificity.

I note everyone is operating under the same principles,

voting should be convenient and safe

Everyone, I am sure, aims to maximize the number of voters who can/will participate in November

The Reality in which we live is that Districts have different historical voting patterns.

Supervisor Gioia pointed out voters in his District 1 habitually vote in person.

Other districts might have voters who predominantly vote by mail.

Could a solution involve some flexibility in thinking?

Could Districts with different voting profiles have different numbers of polling sites? or is that an equity issue, despite verifiable voting habits?

I agree with Supervisor Gioia that 6 in-person voting sites are inadequate. Even with the options of ballot return by mail and the availability of a plethora of voting boxes to smooth the processing of large numbers of voters, 6 in-person sites is not a reasonable number. There are people who actually need help voting in addition to those who simply prefer voting in person. If we are serious about making voting ubiquitous, we need to make voting easy and secure. I think volunteers will rise to the challenge of staffing all the voting sites you establish.
