RE Resolution #2020/306 and the Office of Racial Equity and Social Justice

We strongly commend the Contra Costa Board of Supervisors for their leadership and resolve in addressing systemic inequities in our County through the creation of a County Office of Racial Equity and Social Justice (Office).

The emphasis on creating a separate independent body that reports directly to you and launching this effort with significant community engagement signals the possibility for realizing the changes called for in the mission and goals of the project.

And, by passing a resolution that recognizes racism as a public health crisis closely after passing the Climate Emergency Resolution, the Board of Supervisors will have addressed the twin challenges that must be addressed together as we move forward to make our climate and society more healthy and livable for all.

Climate change is a threat multiplier for social, health and security concerns of our nation and our local communities. Moving ahead to achieve the mission of the Office will require that our elected and community leadership see the intersections of racial and social justice equity with the threats and growing impacts of climate change. To do this, it is imperative that the new office understand that its role in expanding racial equity and social justice must look deeply to address disparities that affect healthy air, affordable & accessible transportation, access to affordable housing near employment and living wage jobs that can provide economic security for families. We must work for reduced disparities in the growing shadow of climate change, acting on our commitment to reduce the risk of climate change with specific, measurable solutions.

A key policy for the County to embrace fully is a focus on Just Transition for communities and workers away from the fossil fuel industry operations and jobs that have been a source of economic well-being for many for a long time. Planning for a Just Transition is a critical path in addressing the climate threat and in achieving climate solutions with attention to racial and environmental justice. It is also a prudent course, as the vulnerabilities of the fossil fuel industry in our county could leave the County and taxpayers exposed should any abrupt industry decisions create more sudden job loss and environmental cleanup that could place high economic burdens on the county and taxpayers and individual workers. This intent to address Just Transition planning, while stated in the recent Climate Emergency

Resolution, can benefit from specific objectives and timetables and needs to be coordinated with the new Office.

With the lingering challenges of COVID, we need to keep a focus on a Just Economic Recovery plan that will incorporate racial and social justice as it addresses climate solutions and climate resiliency with equity at the center. We may soon see a Federal bailout for cities and Counties. 350 Contra Costa hopes that, in light of our County's strong stance on addressing the climate emergency, racism and social injustice, that we can take advantage of just recovery funding for infrastructure and other needs for which the funds will be targeted.

Thank you for your leadership stance on racism, social health and economic disparities and in calling attention to the climate emergency and the County role in addressing it.

We look forward to seeing plans unfold that bring our communities together with the County working on these important issues.
