The County uses a [formal process](#) to determine allocations from the Fish and Wildlife Propagation Fund. Applications, which were due on January 6, 2020, are reviewed by the Fish & Wildlife Committee, which makes recommendations to the Board of Supervisors via the Internal Operations Committee (IOC). The Fish & Wildlife Committee is scheduled to make its recommendations to the IOC on April 6. The IOC would likely make its recommendations to the Board of Supervisors on April 21 or 28. While I cannot agendize your proposal, you may avail yourself of the opportunity to provide public comment at any public meeting of the Board or its committees, or the Fish & Wildlife Committee.

Dear Federal,

I read about your goals for the County (Youth job training, urban boundaries, energy independence etc) and wondered if the proposal that I've submitted to the Co Co County FWC is in alignment with those goals.

The proposal underwent an initial review at the meeting on Wednesday, January 15th and will be voted on at the meeting on February 20th at 3pm. At that point, it may be referred to the Board of Supervisors for consideration.

I've proposed a project which will encourage kids to get into the training and education pipeline for the jobs of tomorrow which will help us....

- a) build a more robust electrical grid to achieve energy security and
- b) prepare for, prevent and mitigate these deadly, neighborhood destroying, suburban forest fires.

Again, I'm just asking if this project is in alignment with your goals for the County.

I have asked the Fish & Wildlife Committee for \$2,000 in video production funding to create a video about the scientific principles of conservation from the game wardens' fine money fund, per Section 13103(a) of the California State Fish & Game Code.


