Contra Costa County Deferred Compensation Plan Amendments

WHEREAS, the Contra Costa County Board of Supervisors adopted Resolution No. 2012/298 on June 26, 2012, amending, and restating the current form of the County's Deferred Compensation Plan (I.R.C. § 457); WHEREAS, the Contra Costa County Board of Supervisors would like to amend the County's Deferred Compensation Plan (I.R.C. § 457), to add provisions to allow participants to allocate deferrals to a Roth Elective Deferral Account (§§ 2.19, 2.20 and 4.2); WHEREAS, the Contra Costa County Board of Supervisors would like to amend the County's Deferred Compensation Plan (I.R.C. § 457) to comply with current IRS regulations and pursuant to the SECURE and CARES acts by revising the definitions of "Normal Retirement Age" (§ 2.12) and "Required Beginning Date" (§ 2.18), provisions relating to required minimum distributions (§ 8.4), provisions related to repayments of loans from deferred compensation plan accounts (§ 8.9(d)(2)(C)), and provisions related to distributions from deferred compensation plan accounts to allow coronavirus-related distributions (§ 8.10); and WHEREAS, the Contra Costa County Board of Supervisors would like to amend the County's Deferred Compensation Plan (I.R.C. § 457) to comply with current IRS regulations by eliminating the restriction that prevents a participant who makes an emergency withdrawal from making deferrals under the Plan for six months.

IT IS BY THE CONTRA COSTA COUNTY BOARD OF SUPERVISORS RESOLVED THAT:

1. Effective March 23, 2021, the Contra Costa County Deferred Compensation Plan document is amended as shown on Attachment A hereto; and

2. The Human Resources Director, or designee, is authorized to take all necessary actions to implement the County's Deferred Compensation Plan as amended.
