LEGAL DESCRIPTION

Parcel 62882-1

The PARCEL 62882-1 EASEMENT described in the GRANT EASEMENT DEED to Contra Costa County, State of California by said document, recorded October 21, 2014 under Recorder's Series Number DOC 2014-0181445-00, Official Records of said County, described as follows:

"An easement over, above, across and under a parcel of land described as follows;

Being a portion of that certain parcel of land described in the Grant Deed to the City of San Pablo, recorded January 2, 2009 under Recorder's Series Number DOC 2009-0000065-00, Official Records of said County, described as follows:

Commencing at the southwesterly corner of said lands of the City of San Pablo, said point being coincident with the westerly line of Lot 19 in Block 3 as shown on the map entitled "Map of East Richmond", filed April 6, 1908 in Volume 1 of Maps, at Page 19, Records of Contra Costa County;

1. Thence North 70°22'31" East 7.23 feet along the southerly line of said lands of the City of San Pablo to the **Point of Beginning**;
2. Thence North 25°56'52" West 65.65 feet to the westerly line of said lands of the City of San Pablo, said point being coincident with the westerly line of Lot 18 in Block 3 as shown on said map;
3. Thence North 19°37'29" West 31.96 feet along last said line;
4. Thence North 69°57'10" East 12.55 feet;
5. Thence South 25°56'52" East 97.91 feet to said southerly line of the lands of the City of San Pablo;
6. Thence South 70°22'31" West 16.10 feet along last said line to the **Point of Beginning**.

2. Thence easterly and southerly 16.49 feet along said curve through a central angle of 90°00'00";
3. Thence South 20°22'33" East 7.00 feet to the beginning of a curve concave northwesterly and having a radius of 10.50 feet;
4. Thence southerly and southwesterly 16.49 feet along said curve through a central angle of 90°00'00";
5. Thence South 69°37'27" West 101.75 feet to the westerly line of said Parcel One;
6. Thence North 19°37'37" West 28.00 feet along last said line and said westerly line of Lot 16 to the **Point of Beginning.**

"TO HAVE AND HOLD, all and singular, the rights above described unto the GRANTEE and the GRANTEE's successors and assigns forever"

SUBJECT to all those certain rights described in said deed (Document Number 2015-00003503-00) as:

"The Grantee agrees upon the completion of any of its works hereunder to restore the surface of the ground as near as possible to the conditions in which it was prior to the commencement of said work".

The bearings and distances used in the above description are based on the California Coordinate System 1983, Zone 3, CA-HPGN EPOCH 1991.35. Multiply distances shown above by 1.000677 to obtain ground level distances.
